FIBRA Prologis Reports No Business Disruption from Mexico City Earthquake

MEXICO CITY, Sept. 21, 2017 /PRNewswire/ -- FIBRA Prologis (BMV: FIBRAPL14), a leading owner of Class-A logistics real estate in Mexico, today said that Prologis Mexico employees and their families were all reported safe. The company also said its Mexico City properties are fully operational with no significant damage from the earthquake. Property assessments are continuing.

The Prologis Foundation (affiliated with the company's sponsor) made a significant donation to the Red Cross to support relief efforts and will match employee contributions to the organization.

The company is also offering its Space for Good program to help with the recovery. Space for Good provides rent-free distribution space to nonprofits in need.
