

Vuzix Receives Six-Figure Smart Glasses Follow-on Order from LogistiVIEW to Support Fortune 100 Retail Customer Deployment

- Customer expands smart glasses usage following multi-year engagement with LogistiVIEW and Vuzix

Vuzix M400 smart glasses can overlay augmented-reality cues such as arrows, text, images directly in the picker's field of view, guiding them hands-free through each task. This approach to using vision in the warehouse, powered by computer vision and AI, can boost accuracy, speed up workflows, and slash implementation costs.

"Our WES platform's flexible workflow editor allows vision-picking processes to be built, modified, and easily deployed, enabling rapid productivity improvement across multiple warehouse applications."
