FIBRA Prologis Acquires 438,966 Square Feet Industrial Park

MEXICO CITY, Nov. 21, 2023 /PRNewswire/ -- FIBRA Prologis (BMV: FIBRAPL14), a leading owner and operator of Class-A industrial real estate in Mexico, has acquired a wholly-owned industrial park, comprising three buildings and a reserve land, from a third party located in Monterrey for an aggregate purchase price of US\$32.7 million, including closing costs. The buildings, which comprise 439 thousand square feet of industrial space, are fully leased in US dollars.

"We continue to execute our growth strategy by acquiring assets from our Sponsor and third-party. These assets are located in one of the most active markets in Mexico, driven mainly by nearshoring. We remain committed in continuing delivering shareholder value to our investors," said Luis Gutiérrez, CEO, Prologis Mexico.
