FIBRA Prologis Acquires 0.3 Million Square Feet

MEXICO CITY, July 10, 2024 /PRNewswire/ -- FIBRA Prologis (BMV: FIBRAPL14), a leading owner and operator of Class-A industrial real estate in Mexico, has acquired one building from Prologis located in Reynosa for a purchase price of US\$26.9 million, including closing costs. The facility is fully leased in dollars to a current Prologis customer who is now expanding its operations into Mexico.

"We are on track to meet this year's acquisition guidance. This acquisition, which is part of Prologis' pipeline and was funded with cash from recent capital raises, will bring additional value to our portfolio and shareholders," said Héctor Ibarzabal, CEO, FIBRA Prologis.
