# **Omega Announces Sixteenth Consecutive Increase in Its Quarterly Common Stock Dividend**

HUNT VALLEY, Md.--(BUSINESS WIRE)-- Omega Healthcare Investors, Inc. (NYSE:OHI) today announced that the Company's Board of Directors declared a common stock dividend of \$0.60 per share, increasing the quarterly common dividend by \$0.02 per share over the previous quarter. The common stock dividend is payable Monday, August 15, 2016 to common stockholders of record as of the close of business on August 1, 2016.

As of the date of this release, the Company has approximately 191.7 million shares of common stock and 8.9 million operating partnership units outstanding.

Omega is a real estate investment trust investing in and providing financing to the long-term care industry. As of March 31, 2016, Omega has a portfolio of investments that includes over 900 properties located in 42 states and the United Kingdom and operated by 83 different operators.
