The dividend of \$0.32 per common share is payable January 16, 2017 to shareholders of record on December 30, 2016. This dividend represents an annualized dividend of \$3.84 per common share.

- 6.625% Series F Cumulative Redeemable Preferred (NYSE:EPRprF) dividend of \$0.4140625 per share payable January 16, 2017 to shareholders of record on December 30, 2016
