Other Projects and Opportunities

The following is the last of our series of updates today. This update focuses more general on the on-going work and opportunities outside of the China and Cameroon contracts. This is work which quietly goes on every day which is both currently revenue generating and on work that will continue to move it forward, along with the larger contracts, in the future. The majority of this work is for long-term existing clients, billed and revenue recognized on a monthly basis.

The following is a brief update on the key activities on previously reported projects. The list does not include all of our on-going work or opportunities.

Projects and Contracts

Services Projects:

- Routine field sampling was completed at the Carroll and Dubies OU2 Superfund Site in New York State. This work consists of monitoring groundwater conditions following the completion of a multimillion dollar cleanup we completed in 1997-1998. Groundwater, which was impacted by the disposal of the waste, will be monitored under the requirements of the Record of Decision until the water reaches the specified clean up criteria. Follow up work from the sampling include reporting on the analysis of the samples by a qualified laboratory.
- The previously reported Midwest Environmental Remediation Project has generated additional work in the analysis of the data from the cleanup and the reporting. While no further cleanup work at this site is anticipated there will be limited follow on monitoring work.
- An environmental remediation and monitoring project for a US based multinational corporation (Client Confidential) that we have worked on since 1997 is moving forward to the final remediation step and closure. Currently work plans we have prepared are under review by the regulatory agency and the field work related to the cleanup is dependent on the agency's review. In the meantime, routine groundwater monitoring and reporting continues at the site.
- Local to the Pittsburgh Area, Cardinal Resources Inc. continues to provide "on-call" environmental and regulatory consulting to a financial institution, an expanding commercial enterprise and a custom electronics related manufacturing company. Similar work is also completed for a custom manufacturer in New York State. This work has been growing with the

economy and while no single project is large the combination of work has been significant in helping the Company. It has also lead to referrals for projects ranging from property transfer assessments to more complete site assessments.

- Once the major avenue for our consulting work, our international consulting is currently focused on a single project. This project consists of providing consulting services on environment issues related to day to day operations, acquisition/divestment due diligence, environmental liability determinations, sustainability, and regulatory issues for operations in multiple countries. While in the past we completed remediation projects and monitoring projects internationally, this project is limited to consulting.

Arizona Contract Key Points:

Our work on this project is a combination of services related to environmental permitting, consulting, sampling, reporting, and design coordination as well as systems that will be provided. Specific activities include:

- We have been working with the client to incorporate zero discharge operation in the final pilot plant design. As this is finalized we will be updating the Determination of Applicability which is required by Arizona Department of Environmental Quality.
- As part of the pilot plant, we have been evaluating the in process treatment and removal of sediments in the process.
- Long lead items and proprietary tanks have been paid for and fabricated for the two CRB-40s. As the plant is finalized we will move ahead with the assembly of the systems for the site.

Democratic Republic of the Congo:

There has been a short delay in the order for the two CRB-10s with the assembly date moved from October to early December. All indications and due diligence in the DRC by the Department of Commerce still remains positive. As with all orders, we do not begin procurement and assembly until we receive the down payment for the systems.
