## **Blink Charging's Electric Vehicle Charging Network Exceeds 125,000 Members**

### **Blink's Cloud-Based System Increases 42% Since 2017**

The Blink Network includes over 14,000 deployed EV chargers nationwide. Publicly accessible chargers are available for anyone to charge their cars, however Blink's free membership awards certain additional benefits, including discounted charging fees, streamlined access to public EV charging stations, and a free Blink InCard which can be used to pay for charging at Blink stations. Both guests and members can use the Blink Mobile App to locate Blink Chargers, and use it to choose from various payment options as well.

"Anyone can use Blink Chargers without being a member, so this milestone is a significant indicator of how many EV drivers are active, committed, and engaged with the Blink Network," said Michael D. Farkas, Founder and Executive Chairman of Blink Charging Co. "We are continuing to expand our robust network and deliver on our promise to make EV charging accessible to drivers wherever they may be going."

Blink's membership milestone was announced on the heels of rapid EV charging station expansion throughout the U.S. in both commercial and residential locations.

"It is mission critical to be visible and accessible to drivers," continued Mr. Farkas. "The industry has reached a tipping point, and as drivers begin switching to EV, property owners will be ready to service them."
