FIBRA Prologis Acquires 222,118 Square Feet in Monterrey

MEXICO CITY, July 27, 2021 /PRNewswire/ -- FIBRA Prologis (BMV: FIBRAPL14), a leading owner and operator of Class-A industrial real estate in Mexico, today announced the acquisition of 222,118 square feet of industrial space for a total investment of US\$15.7 million, including closing costs. The property is in Monterrey and was developed by FIBRA Prologis' sponsor, Prologis. The property is fully leased to one of the largest retailers and department store operators in Mexico.

"The addition of this property increases our ownership in one of the best industrial parks in Monterrey, and together with the acquisition we recently announced in Juárez, represents an investment of US\$35 million and 465 thousand square feet," said Luis Gutierrez, CEO, Prologis Mexico. "These properties are in the most desirable sub-markets within Monterrey and Ciudad Juarez, and further evidence that nearshoring and logistics industries are creating incremental demand in Mexico."
