

Mueller Industries, Inc. Declares Cash Dividend for Second Quarter

MEMPHIS, Tenn., May 6, 2011 /PRNewswire/ -- Mueller Industries, Inc. (NYSE: MLI), announced today that its Board of Directors has declared a regular quarterly dividend of 10 cents per share on its common stock. The dividend will be payableJune 15, 2011, to shareholders of record on June 1, 2011.
