

Cemtrex Announces First VR Game, Ultra85, To Be Released in June 2018

FARMINGDALE, N.Y., March 15, 2018 (GLOBE NEWSWIRE) -- Cemtrex Inc. (Nasdaq:CETX)(Nasdaq:CETXP)(Nasdaq:CETXW), a world leading technology and manufacturing company, today announced that it plans to release an original content virtual reality (VR) gaming experience entitled, Ultra85. This game is being developed in-house by the Company's recently formed CemtrexVR team (www.cemtrexvr.com) for Steam VR and Oculus.



Designed and developed as a VR-only experience from the ground up, Ultra85 blends classic arcade mechanics with immersive physics-based sword combat. Inspired by the action flicks and 8-bit games of the 80s - Ultra85 explores the experimental overlap between the traditional comic book format and interactive gameplay.

CemtrexVR's team in NYC is currently working through core game mechanics and story development for the first chapter of Ultra85, which is slated to release in early access on Steam and the Oculus Store in June.

The VR Gaming market in 2016 was estimated at \$3.6 billion and is expected to reach \$22 billion by 2020, according to market research from Statista. Adoption is expected to pick up particularly with the upcoming release of Oculus <u>Go</u> this spring and from recent announcements from <u>Google</u> and Magic Leap.

Cemtrex's Chairman and CEO, Saagar Govil commented, "The virtual reality gaming industry is slated to explode similarly to how the mobile app industry did after the iPhone was released. With rapid innovation in headsets taking place every day we anticipate that

VR adoption will continue to exceed expectations. Our strategy is to position Cemtrex in multiple verticals within virtual reality markets to leverage the rapid growth in the industry with our competencies in software development. We will continue to explore opportunities to develop original content, collaborative experiential applications, and games as we aim to create new high growth revenue streams for our Company."
