Blüm RULES AND REGULATIONS

MEDICAL MARIJUANA ESTABLISHMENT Blüm is a Nevada-licensed Medical Marijuana Establishment dedicated to providing the highest quality of care and services for qualified medical cannabis patients, consistent with the limitations and rights established by Chapter 453A-Medical Use of Marijuana of the Nevada Administrative Code. Those regulations and the following rules apply to all patients and caregivers who enter this Medical Marijuana Establishment. Any violation of these rules is grounds for immediate termination of any relationship between the parties.

PHYSICIAN RECOMMENDATIONS AND REGISTRY CARDS Patients at Blüm must have a recommendation for medical cannabis by a licensed doctor of medicine or doctor of osteopathy as required by Nevada law. Patients must provide Blüm with a current valid government-issued photo identification card, along with their current valid Nevada Medical Marijuana Registry Card or a current valid nonresident medical marijuana card issued by state or jurisdiction other than Nevada, upon each visit to Blüm to enter the sales area and/or to make a purchase.

CONFIDENTIALITY All personal information collected by Blüm is confidential and private. Such information will not be released to any third party without your written consent. However, Blüm may be required by court order or by the Nevada Division of Public and Behavioral Health to release certain information and Blüm must comply.

NO RESALE OR REDISTRIBUTION OF MEDICAL CANNABIS Resale or redistribution of any medical cannabis products received from Blüm is strictly prohibited by law. Patient agrees he/she shall not sell or redistribute medical cannabis products from Blüm.

USE OF CELL PHONES, CAMERAS, RECORDING DEVICES, OR ELECTRONIC COMMUNICATION DEVICES, OR RECORDING DEVICES IS PROHIBITED BEYOND THE WAITING ROOM. WEAPONS OF ANY KIND ARE NOT ALLOWED ON THE PREMISES.

NO PUBLIC USE OR ONSITE CONSUMPTION The use of medical cannabis in public view is illegal in the state of Nevada. Consumption of medical cannabis, illegal drugs, tobacco or alcohol on the entire premises of Blüm is strictly prohibited.

PRE-ORDERS After pre-orders services become available, patients and caregivers who call ahead or use the online pre-order system to reserve products are given priority and skip ahead in line.

PAYMENT FOR SERVICES Payment is expected at time of transaction/service. Patients are not allowed to touch any of the items containing medical cannabis until their transaction is complete. To comply with state medical marijuana laws, refrain from opening your purchases until after you leave the premises. Credit card use will be permitted for patients only.
