

## Mike Krzyzewski Debuts 10th Season of His SiriusXM Show Oct. 23

He was inducted into the Naismith Basketball Hall of Fame in 2001.

Krzyzewski has been involved with USA Basketball as a coach on and off since 1979, when he started out as an assistant to Bob Knight. Over that time he has helped lead the U.S. to 10 gold medals, two silver medals and two bronze medals. Since 2005, when USA Basketball managing director Jerry Colangelo selected Krzyzewski as the Senior Men's National Team head coach, the USA is an extraordinary 75-1 in major international competitions.
