Energy Recovery will be supplying IDE with several of the Company's PX PowerTrains™.

The <u>PX PowerTrain solution</u> combines Energy Recovery's award-winning PX® Pressure Exchanger® ("PX") devices with frame support and ancillary equipment into a compact, ready to install, high-performance ERD solution.
