



Company Overview

Ur-Energy owns and operates the Lost Creek in-situ recovery uranium facility in south-central Wyoming. Lost Creek received an amendment to its license allowing expansion of mining activities within the existing Lost Creek Project and the adjacent LC East Project. The license allows annual plant production up to 2.2 million pounds U₃O₈, which includes wellfield of up to 1.2 million pounds U₃O₈ and toll processing of up to one million pounds U₃O₈. Our second uranium in-situ recovery facility, Shirley Basin Project, is licensed and permitted, and we expect production to commence in Q1 2026.

Ur-Energy engages in the identification, acquisition, exploration, development, and operation of uranium projects. Shares of Ur-Energy trade on the NYSE American under the symbol "URG" and on the Toronto Stock Exchange under the symbol "URE." Ur-Energy's corporate office is located in Littleton, Colorado; its registered office is in Ottawa, Ontario.
