Charitable contributions or pledges within any given fiscal year in an aggregate amount of \$50,000 or are subject to the prior review and approval of the Corporate Governance and Nominating Committee of the BD Board of Directors.

These contributions and pledges reflect BD's Social Investing philosophy, which involves formulating and executing strategic initiatives with community partners to create healthier communities worldwide, demonstrate BD's social responsibility, and build relationships in support of BD's corporate goals. The primary objectives are to:

- Align and concentrate support on healthcare programs and initiatives that address key issues in communities where BD has operations, and where its core competencies and resources can be leveraged most effectively; and
- Support programs where BD maintains facilities or has a significant presence to apply local BD resources to local community needs.

BD aligns its giving under three pillars:

- Expanding Healthcare Access Focus on underserved populations that face barriers to care, health equity
- Advancing Human Potential Support racial, ethnic and gender equality and opportunities
- Supporting Resilient Communities Reinforce disaster preparedness, response and recovery efforts
