FIBRA Prologis Acquires 651,258 Square Feet

MEXICO CITY, June 19, 2023 /PRNewswire/ -- FIBRA Prologis (BMV: FIBRAPL14), a leading owner and operator of Class-A industrial real estate in Mexico, has acquired three buildings from Prologis located in Ciudad Juarez, Monterrey, and Tijuana for an aggregate purchase price of US\$74.9 million, including closing costs. The buildings, which comprise 651,258 square feet of industrial space, are fully leased in US dollars.

"We continue to proactively execute our strategy of building a stronger presence in the best industrial border markets that can meet growing demand," said Luis Gutiérrez, CEO, Prologis Mexico. "These assets are part of the pipeline we announced during our follow-on transaction."
