

Microchip Technology Declares Record Quarterly Cash Dividend and 9.4% Increase in Dividend Rate from a Year Ago

CHANDLER, Ariz.--(BUSINESS WIRE)--

Microchip Technology Incorporated (NASDAQ: MCHP), a leading provider of microcontroller and analog semiconductors, today announced that its Board of Directors has declared a quarterly cash dividend on its common stock and increased the dividend to 33.9 cents per share. The dividend is payable on November 28, 2008 to stockholders of record on November 14, 2008. Microchip initiated quarterly cash dividend payments in the third quarter of fiscal year 2003 and has increased the cash dividend by 9.4% from the dividend level one year ago.

"The Board is pleased to declare a dividend increase of 9.4% from the dividend level of a year ago, particularly in light of the current challenges facing the global equity and credit markets," said Steve Sanghi, President and CEO. "Net cash generated for the six months ended September 30, 2008 was \$247.7 million, representing the cornerstone of our strategy of returning value to our investors through our dividend policy."
