

# Phunware Provides Upwardly Revised Financial Guidance for Application Transactions Business

### Announces Customer Wins and Google Firebase Product Integration

AUSTIN, Texas--(BUSINESS WIRE)-- Phunware, Inc. (NASDAQ: PHUN) (the "Company"), a fully-integrated enterprise cloud platform for mobile that provides products, solutions, data and services for brands worldwide, announced today that it has upwardly revised the financial guidance previously provided for its Application Transactions business. The Company currently projects that its non-recurring media transaction revenues will increase by more than 60% quarter-over-quarter, with strong growth specific to new media sales wins on mobile.

Since inception in 2009, Phunware has helped brands of all sizes navigate the complex ecosystem of mobile and digital advertising, allowing customers to engage audiences and drive business outcomes and results for digital transformation. The Company provides best-in-class mobile advertising software, tools and services, including expertise with media strategy and planning, mobile-first creative development, custom audience creation and campaign management and optimization, as offerings within its core <a href="Multiscreen-as-a-Service (MaaS)">Multiscreen-as-a-Service (MaaS)</a> enterprise cloud platform for mobile.

The majority of Phunware's Application Transactions business growth in the current quarter has largely been attributable to the travel industry, where the Company has seen a 90% increase in campaign wins as more markets and geographies begin reopening from the COVID-19 pandemic shutdowns within the hospitality and real estate verticals. In parallel, Phunware continues to see strong activity and engagement within government agencies and organizations, including new customers such as <u>California Operation Lifesaver (CAOL)</u>, which conducts its work on behalf of the <u>Federal Railroad Administration (FRA)</u> and the <u>Federal Highway Administration (FHWA)</u>, both divisions of the <u>United States Department of Transportation (USDOT)</u>.
