

## VF Announces Organizational Changes and New Group Presidents Role

GREENSBORO, N.C.-- VF Corporation (NYSE: VFC) announced today the promotion of two executives, Steve Rendle and Scott Baxter, to the newly-created position of Group President.

Rendle and Baxter will join Salzburger as members of VF's Operating Committee.

Salzburger, Rendle and Baxter will all continue to report to VF Chairman and Chief Executive Officer, Eric Wiseman.
