

Q2 2023 Key Financial Highlights

- 1. Herbalife reports Q2 2023 net sales of ~\$1.3B, down 5.7% YoY; down 4.2% YoY on constant currency basis¹
 - YoY reported net sales trends improved for 2 sequential quarters
- Q2 gross profit margin of 77.0% negatively impacted by ~90 bps FX headwind YoY; sequentially improving from Q1 2023
- 3. Q2 adjusted EBITDA² of ~\$170M includes ~\$17M FX headwind adjusted EBITDA margin 12.9%; both sequentially improving from Q1 2023
- 4. Q2 adjusted diluted EPS² of \$0.74 includes \$0.12 FX headwind
- 5. At current rates, FX expected to be modest tailwind in Q4 2023
- 6. Transformation Program annual cost savings now expected to reach at least \$90M (up from more than \$70M) in 2024 and beyond, with more than \$45M anticipated to be realized in 2023 (up from ~\$35M)
 - Pre-tax expenses of ~\$10M recognized in SG&A in Q2 and excluded from adjusted results
 - Expect to incur total program pre-tax expenses of at least \$75M (up from at least \$60M); \$62M incurred to date





(% Change vs Prior Year)








Adjusted EDITDA¹ Margin Bridge

(% Change vs Prior Year)



Average Active Sales Leaders Relatively Flat vs Q1 2023, Above 2019 Levels


Average Active Sales Leaders¹

Capital Structure Update

- ~\$527 million of cash on hand at Jun 30 '23, up ~\$72M from Mar 31 '23
- \$330M revolving credit facility remains fully undrawn at Jun 30 '23
- Gross leverage ratio of ~3.7x at Jun 30 '23; compliant with all debt covenants as of Jun 30' 23
- Effective Jul 1 '23, benchmark rate for Senior Secured Credit Facility set to SOFR, Secured Overnight Financing Rate, LIBOR no longer referenced
- Capex to remain elevated in 2023 2025 as a result of Herbalife One digital technology platform
 - o Capex of ~\$69M during six months ended Jun 30 '23, including Herbalife One
 - Expect ~\$150M to \$200M of total capex, including Herbalife One, for FY 2023
- Long-term capital allocation strategy unchanged
 - Debt service, with targeted gross leverage ratio of 3.0x
 - Internal investments
 - External investments
 - Return cash to shareholders

Supplemental Information

Non-GAAP Financial Measures

Adjusted SG&A, Adjusted EBITDA, Adjusted Net Income and Adjusted Diluted EPS

In addition to its reported results calculated in accordance with GAAP, the Company has included in this presentation adjusted SG&A, adjusted EBITDA, adjusted net income and adjusted diluted EPS, performance measures that the Securities and Exchange Commission defines as "non-GAAP financial measures." Adjusted SG&A, adjusted EBITDA, adjusted net income and adjusted diluted EPS exclude the impact of certain unusual or non-recurring items such as net expenses related to COVID-19 pandemic, expenses related to Transformation Program, expenses related to digital technology program and charges related to the Russia-Ukraine conflict, as further detailed in the reconciliations included herein. Adjusted EBITDA margin represents adjusted EBITDA divided by net sales.

Management believes that such non-GAAP financial measures, when read in conjunction with the Company's reported results, calculated in accordance with GAAP, can provide useful supplemental information for investors because they facilitate a period to period comparative assessment of the Company's operating performance relative to its performance based on reported results under GAAP, while isolating the effects of some items that vary from period to period without any correlation to core operating performance and eliminate certain charges that management believes do not reflect the Company's operations and underlying operational performance. The Company's definition and calculation as set forth in the reconciliations of adjusted SG&A, adjusted EBITDA, adjusted net income and adjusted diluted EPS included herein, may not be comparable to similarly titled measures used by other companies because other companies may not calculate them in the same manner as the Company does and should not be viewed in isolation from nor as alternatives to selling, general, and administrative expenses, net income or diluted EPS calculated in accordance with GAAP.

Currency Fluctuation


Our international operations have provided and will continue to provide a significant portion of our total net sales. As a result, total net sales will continue to be affected by fluctuations in the U.S. dollar against foreign currencies. In order to provide a framework for assessing how our underlying businesses performed excluding the effect of foreign currency fluctuations, in addition to comparing the percent change in net sales from one period to another period using "net sales in local currency." Net sales in local currency is not a measure presented in accordance with U.S. GAAP. Net sales in local currency removes from net sales in U.S. dollars the impact of changes in exchange rates between the U.S. dollar and the local currencies of our foreign subsidiaries, by translating the current period net sales into U.S. dollars using the same foreign currency exchange rates that were used to translate the net sales for the previous comparable period. We believe presenting net sales in local currency is useful to investors because it allows a meaningful comparison of net sales of our foreign operations from period to period. However, net sales in local currency should not be considered in insolation or as an alternative to net sales in U.S. dollar measures that reflect current period exchange rates, or to other financial measures calculated and presented in accordance with U.S. GAAP. In addition to its reported results calculated in accordance with U.S. GAAP, the Company has included herein net sales, EBITDA, net income and diluted EPS adjusted for FX translation, which are considered "non-GAAP financial measures". Management believes that such non-GAAP financial measures, when read in conjunction with the Company's reported results, can provide useful supplemental information for investors when analyzing period to period comparisons of the Company's results.




Net Sales

(% Change vs Prior Year)









Adjusted EDITDA¹ Margin Bridge
