## **Steven Engle Appointed Chairman of XOMA**

BERKELEY, Calif., Oct. 8, 2007 (PRIME NEWSWIRE) -- XOMA Ltd. (Nasdaq:XOMA), a leader in the discovery and development of antibody therapeutics, today announced the appointment of its Chief Executive Officer and President, Steven Engle, as Chairman of the Board of Directors effective October 5, 2007. Mr. Engle joined XOMA as its Chief Executive Officer and President and a Director in August 2007.

Mr. Engle succeeds John L. (Jack) Castello, who had been Chairman, Chief Executive Officer and President of XOMA. Mr. Castello announced his plan to retire in February 2007 and agreed in August to continue serving on the Board as its non-executive Chairman through a transition period.

Mr. Engle stated, "Under Jack Castello's leadership, XOMA has developed the financial resources, experienced team and antibody technology and capabilities required for successful product development and long-term growth. We appreciate his contributions and wish him all the best in his retirement."

XOMA is a leader in the discovery, development and manufacture of therapeutic antibodies, with a therapeutic focus that includes cancer and immune diseases. XOMA has royalty interests in RAPTIVA(r) (efalizumab), a monoclonal antibody product marketed worldwide (by Genentech, Inc. and Merck Serono S.A.) to treat moderate-to-severe plaque psoriasis, and LUCENTIS(r) (ranibizumab injection), a monoclonal antibody product marketed worldwide (by Genentech and Novartis AG) to treat neovascular (wet) age-related macular degeneration.

The company has built a premier antibody discovery and development platform that includes access to seven of the leading commercially available antibody phage display libraries and XOMA's proprietary Human Engineering(tm) and bacterial cell expression (BCE) technologies. More than 45 companies have signed BCE licenses. XOMA's development collaborators include Lexicon Pharmaceuticals, Inc., Novartis, Schering-Plough Research Institute and Takeda Pharmaceutical Company Limited. With a fully integrated product development infrastructure, XOMA's product development capabilities extend from preclinical sciences to product launch.
