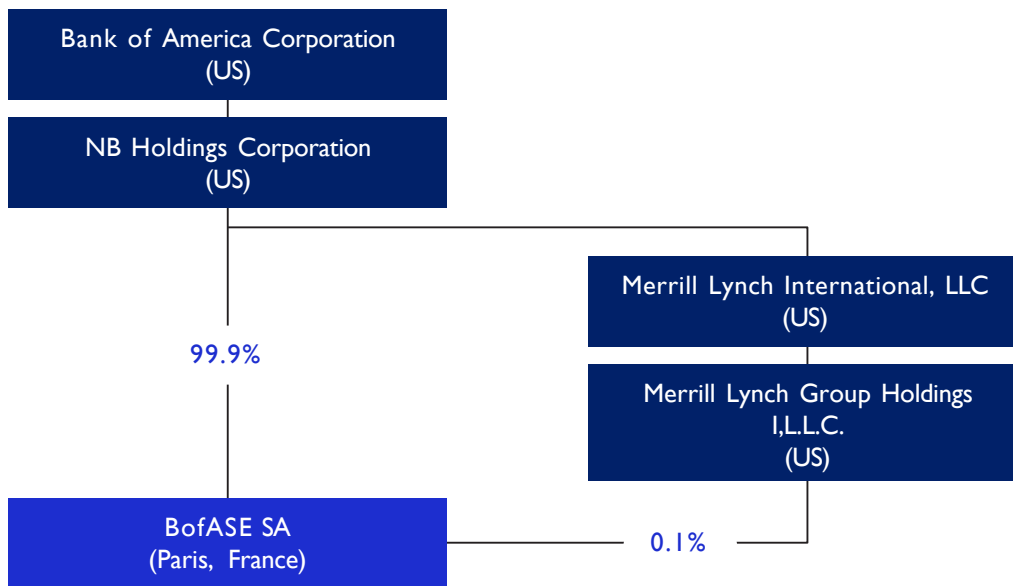

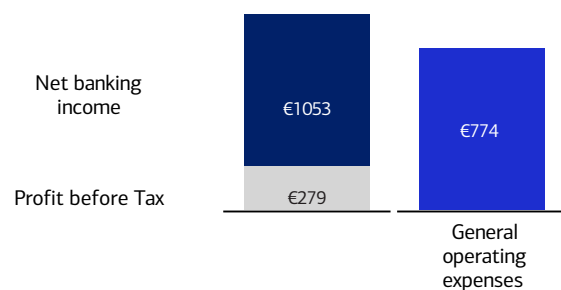

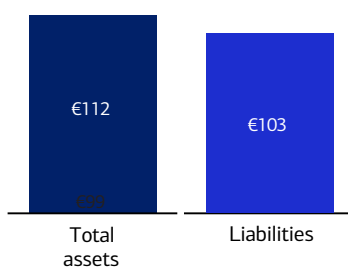
BofASE financial performance (French GAAP in €millions)

Financial position – as of 31 December 2025

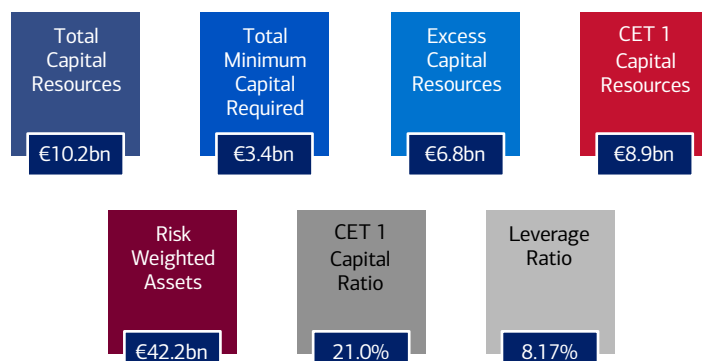
Balance sheet composition (€bn)
