

ProLogis Expands Lease Agreement With SpeedFC in Dallas

-- Customer Takes an Additional 268,000 Square Feet of ProLogis' Development Portfolio, Doubling its Current Occupancy at ProLogis Northgate Distribution Center --

SpeedFC initially leased 268,000 square feet at ProLogis Northgate Distribution Center Building 18 in May 2008. With the signing of this lease in the third quarter, SpeedFC will double its presence in the center. SpeedFC will use the additional space to accommodate the growth of its business, providing third-party fulfillment, call center and Web development services to consumer and business-to-business companies.

"SpeedFC now leases 854,000 square feet from ProLogis in both Dallas and Columbus, and we are pleased to grow our relationship with this important customer," said Rob Huthnance, first vice president and market officer for ProLogis. ProLogis Northgate Distribution Center is located in northeast Dallas off Interstate 635, halfway between Interstate 30 and Highway 75. ProLogis' portfolio in the submarket comprises 14 buildings totaling approximately 2.6 million square feet. ProLogis Northgate Distribution Center Building 18, totaling approximately 535,000 square feet, was completed in January of 2008 and is now fully occupied.

ProLogis is one of the largest providers of distribution space in Dallas/Fort Worth with a 23.3-million-square-foot portfolio. Additional ProLogis customers in the area include DHL, Sears, Siemens Government Services, APL Logistics, UPS and Xerox.
