

Prologis Announces Sale of 7.5 Million Square Foot Portfolio in United States

SAN FRANCISCO, June 18, 2014 /PRNewswire/ -- Prologis, Inc. (NYSE: PLD), the global leader in industrial real estate, today announced the closing of the sale of a 7.5 million square foot industrial portfolio in the United States to TPG, a leading global private investment firm.

The portfolio includes 59 properties located across nine markets, including: Columbus, OH; Chicago; Cincinnati; Dallas; Denver; El Paso, TX; Los Angeles; Portland, OR; and Seattle.
