

## Capstone Receives Additional C1000 Orders for Oil & Gas in U.S. and Russian Markets

CHATSWORTH, Calif., April 4, 2011 (GLOBE NEWSWIRE) -- Less than three months after announcing two orders totaling nine megawatts for a large U.S. independent oil and gas company, Capstone Turbine Corporation (<a href="www.capstoneturbine.com">www.capstoneturbine.com</a>) (Nasdaq:CPST), the world's leading clean technology manufacturer of microturbine energy systems, received another follow-on order for six C1000 Power Packages to be delivered to the U.S. market later this year. Capstone distributor Pumps & Service, which secured the previous order for nine megawatts for projects operating in the Eagle Ford Shale play in South Texas, had indicated they expected more orders in 2011. Today's announcement is the sixth major order Pumps & Service has placed with Capstone in recent months for units sold to large independent oil and gas companies operating primarily in the shale plays.

In addition, the Company received orders for eleven C1000s from its largest international distributor, BPC in Russia. The majority of the C1000s ordered from BPC will be deployed in the Russian oil and gas markets. The Company has seen a significant increase in order activity from BPC for several ongoing oil and gas projects.

"Oil and gas producers are beginning to appreciate the high reliability and low maintenance costs of the Capstone microturbine and the important role Capstone products can play in solving customers' energy requirements," said Sam Henry, Pumps & Service President.

"Market adoption of the C1000 product appears to be accelerating in both the U.S. and Russian oil and gas markets," said Darren Jamison, Capstone's President and Chief Executive Officer. "Both our key U.S. and Russian oil and gas distributors are doing a tremendous job in the sales, application, marketing and service of the Capstone C1000 Series product," added Jamison.
