

## **Deluxe Announces Inducement Grants for Newly Hired CTO**

In each case, upon vesting, each RSU will convert into a share of the company's common stock. Subject to certain exceptions, vesting is contingent upon continued employment. The shares were awarded on the same date as other new hire stock awards, consistent with business practice.
