

Cleveland-Cliffs Announces Price Increase for Flat-Rolled Steel Products

CLEVELAND--(BUSINESS WIRE)-- Cleveland-Cliffs Inc. (NYSE: CLF) today announced that it is increasing current spot market base prices for all carbon hot rolled, cold rolled and coated steel products by a minimum of \$50 per net ton, effective immediately with all new orders. Cliffs' minimum base price for hot rolled steel is now \$950 per net ton.
