Under GAAP, NMFC's IPO did not step-up the cost basis of the predecessor operating company's existing investments to fair market value. Since the total value of the predecessor operating company's investments at the time of the IPO was greater than the investments' cost basis, a larger amount of amortization of purchase or issue discount, and different amounts in realized gains and unrealized appreciation, may be recognized under GAAP in each period than if a step-up had occurred. - Q3 2025 adjusted net investment income (“NII”) of \$0.32 covered our dividend of \$0.32 per share⁽¹⁾
 - NII was supported by recurring income, full utilization of the dividend protection program, and a modest incremental incentive fee waiver
- Announcing Q4 2025 dividend of \$0.32 per share payable on December 31, 2025 to holders of record as of December 17, 2025
 - Dividend is supported by strong recurring earnings and the dividend protection program in place through the fourth quarter of 2026⁽²⁾
- September 30, 2025 net asset value (“NAV”) of \$12.06 per share compared to \$12.21 per share as of June 30, 2025
 - Stable credit performance across the portfolio offset by modest declines across four positions
 - ~95% of the portfolio is rated green on our heatmap and ~80% of the portfolio is senior in nature⁽³⁾⁽⁴⁾
- Exploring a secondary portfolio sale of up to \$500 million of assets to a third party to further NMFC’s strategic initiatives
 - If successful, this sale could reduce PIK income, diversify our largest positions, and enhance financial flexibility in 2026
- Repurchased ~\$47 million of NMFC shares year to date⁽⁵⁾ at a weighted average purchase price of \$10.02 per share, including commissions paid
 - Fully utilized the previously announced \$50 million board authorized stock repurchase program
 - Announcing a new \$100 million board authorized share buyback program
- New Mountain employees continue to be the largest shareholders of the Company, with ownership of ~14%

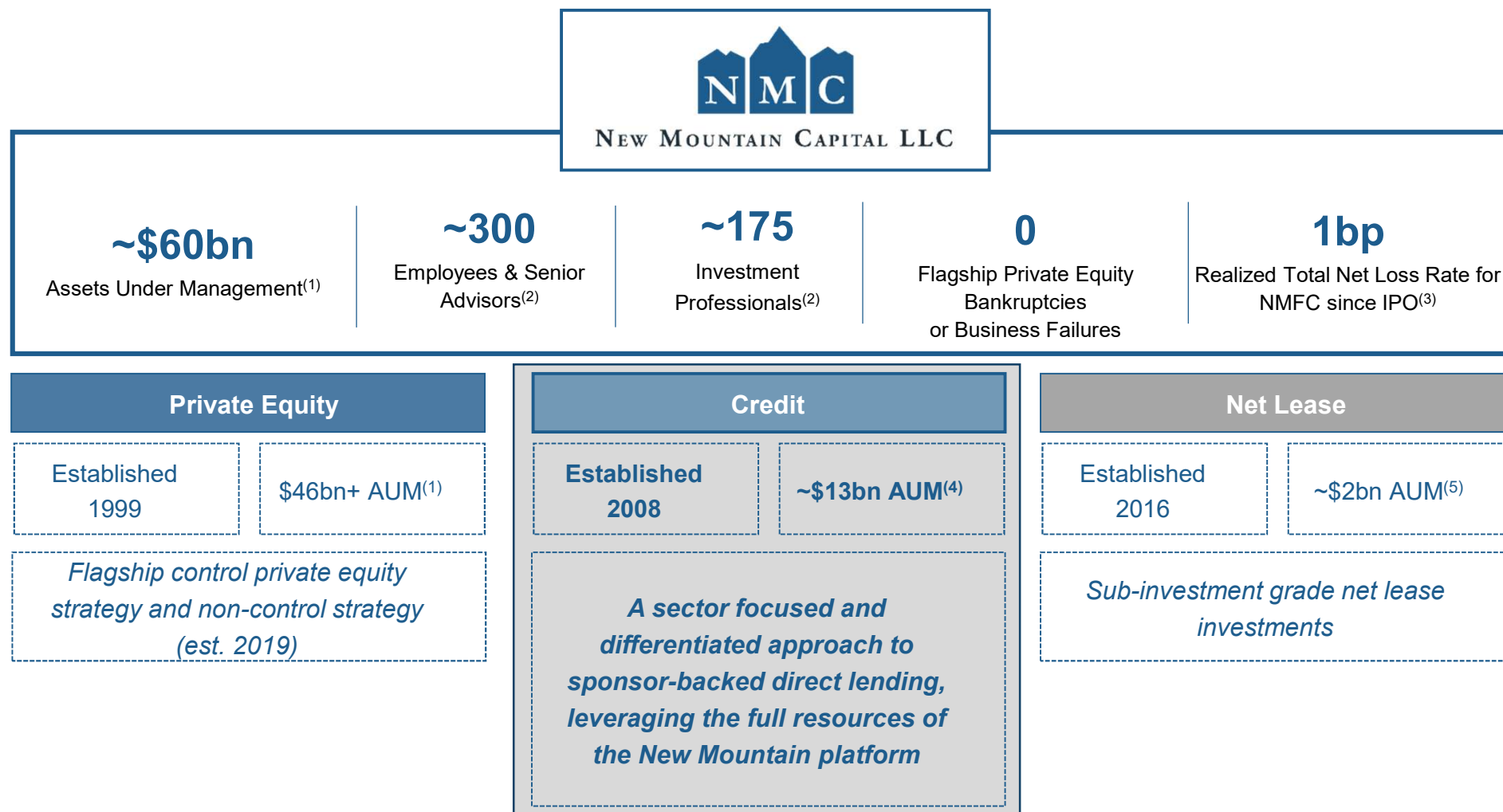

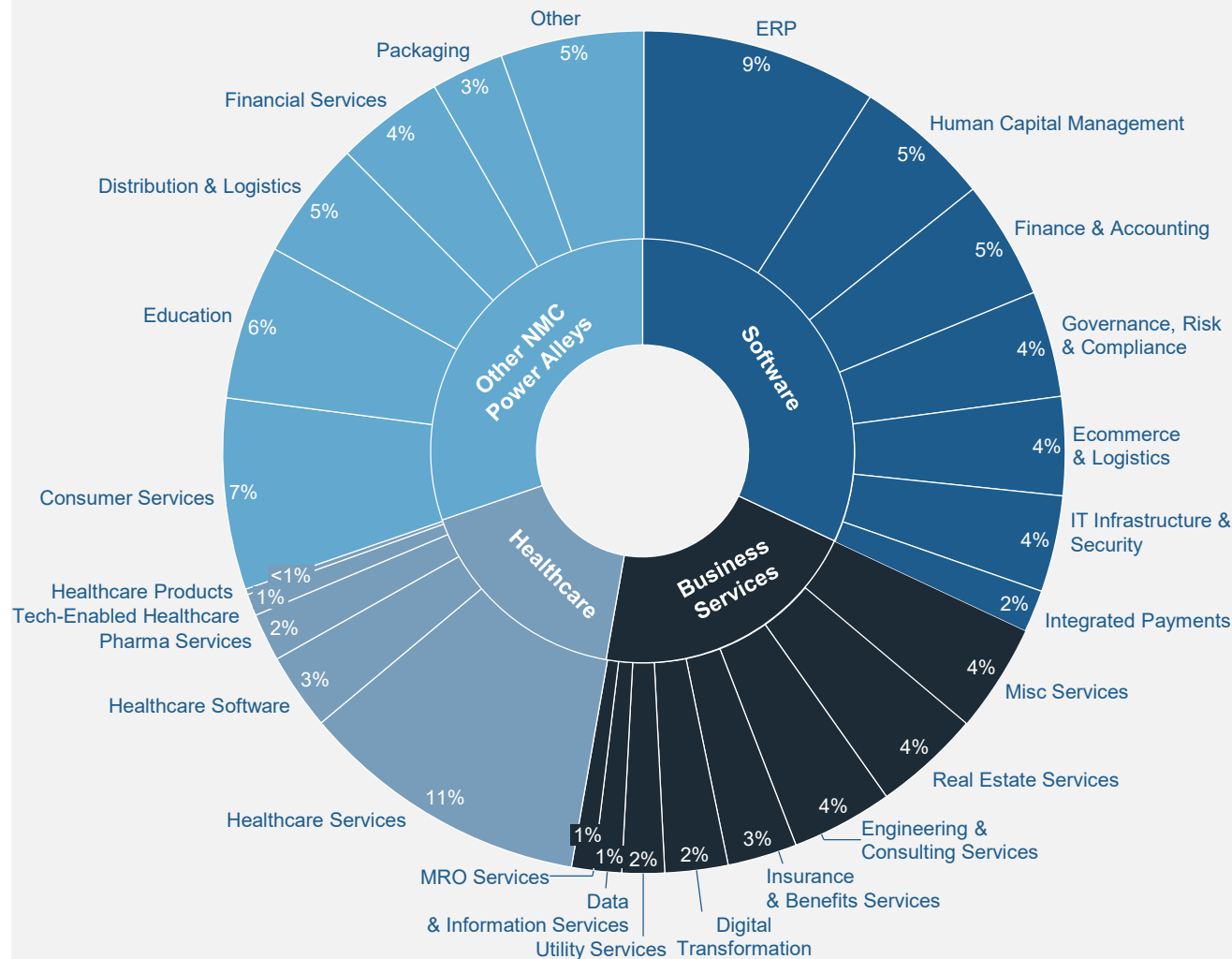

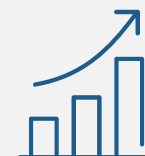

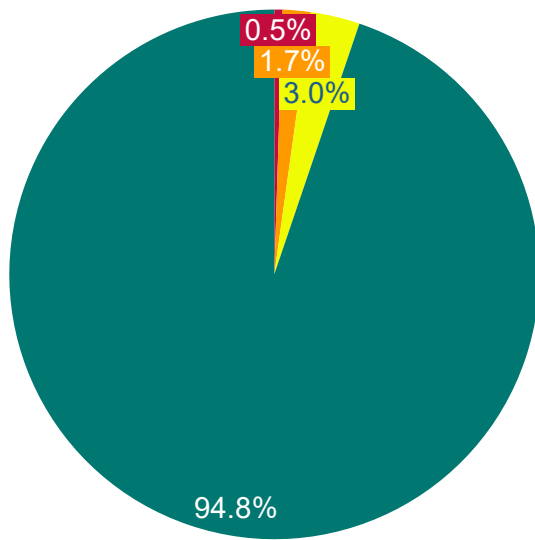

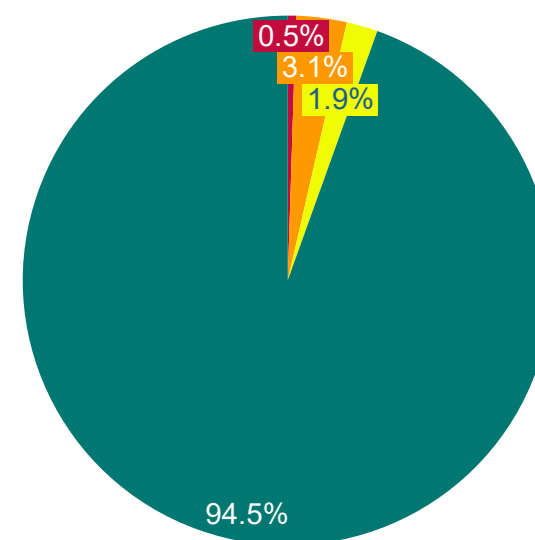

Q3 2025 Risk Ratings (Fair Value as of 9/30/2025)

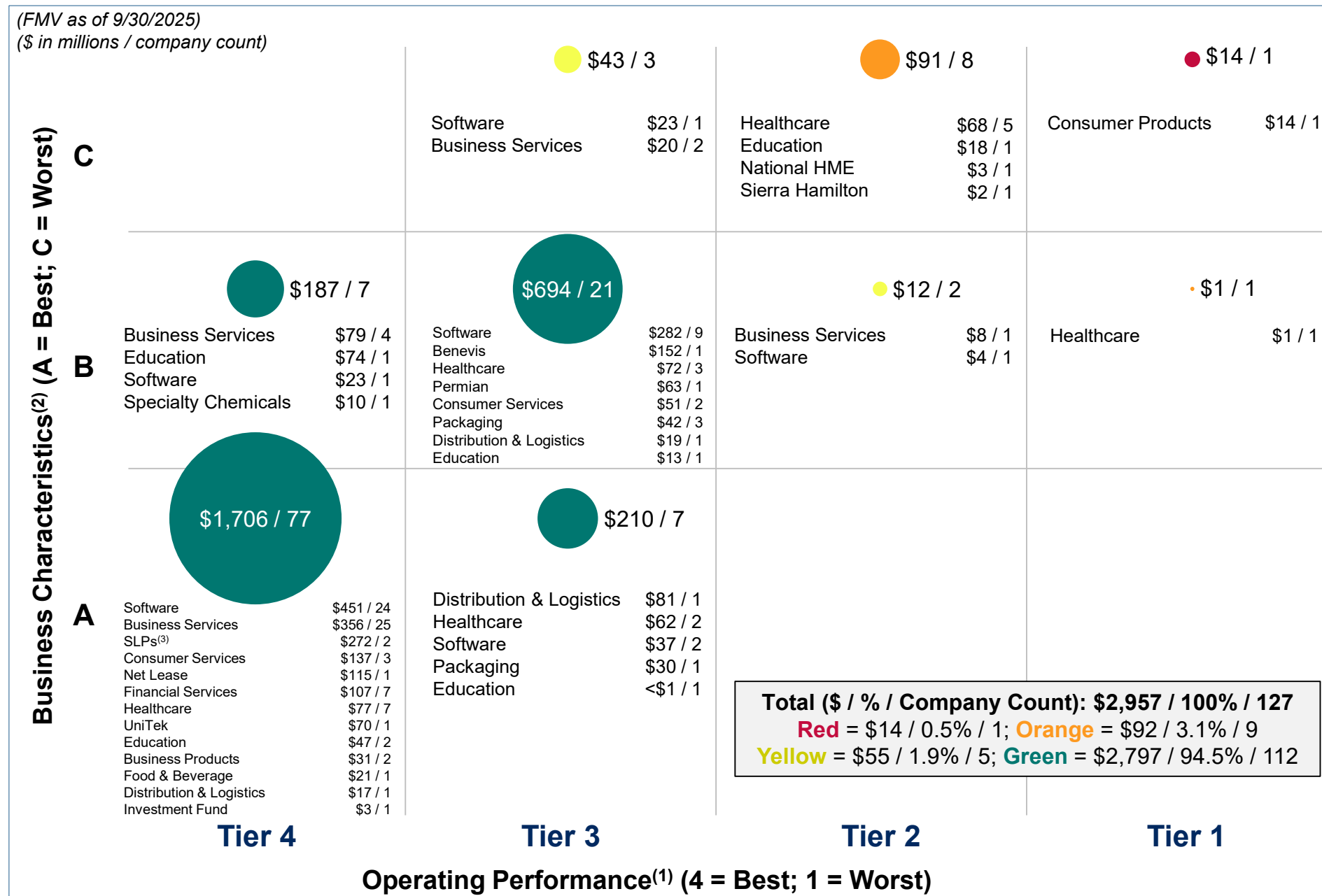

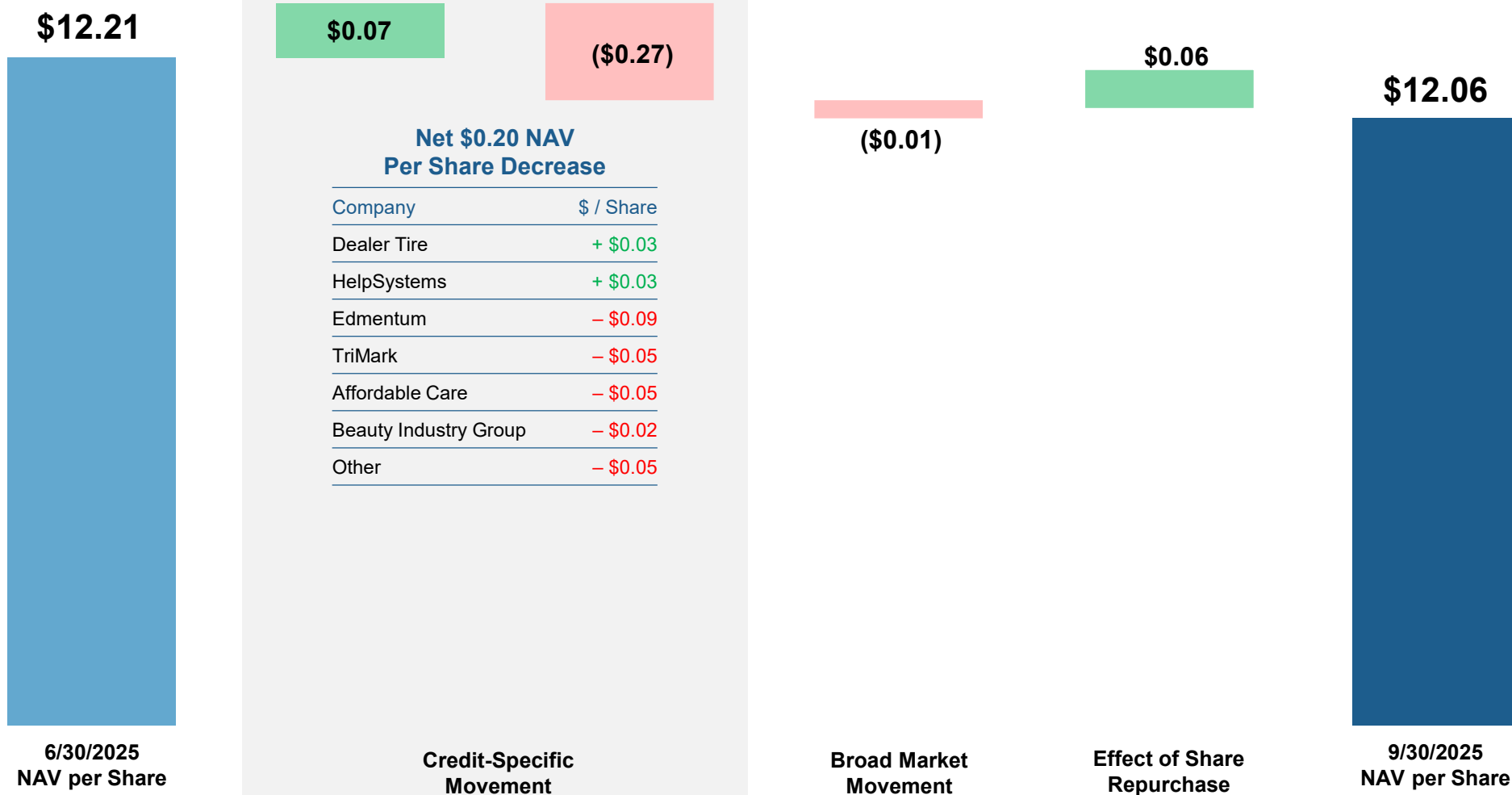

Portfolio – Risk Ratings



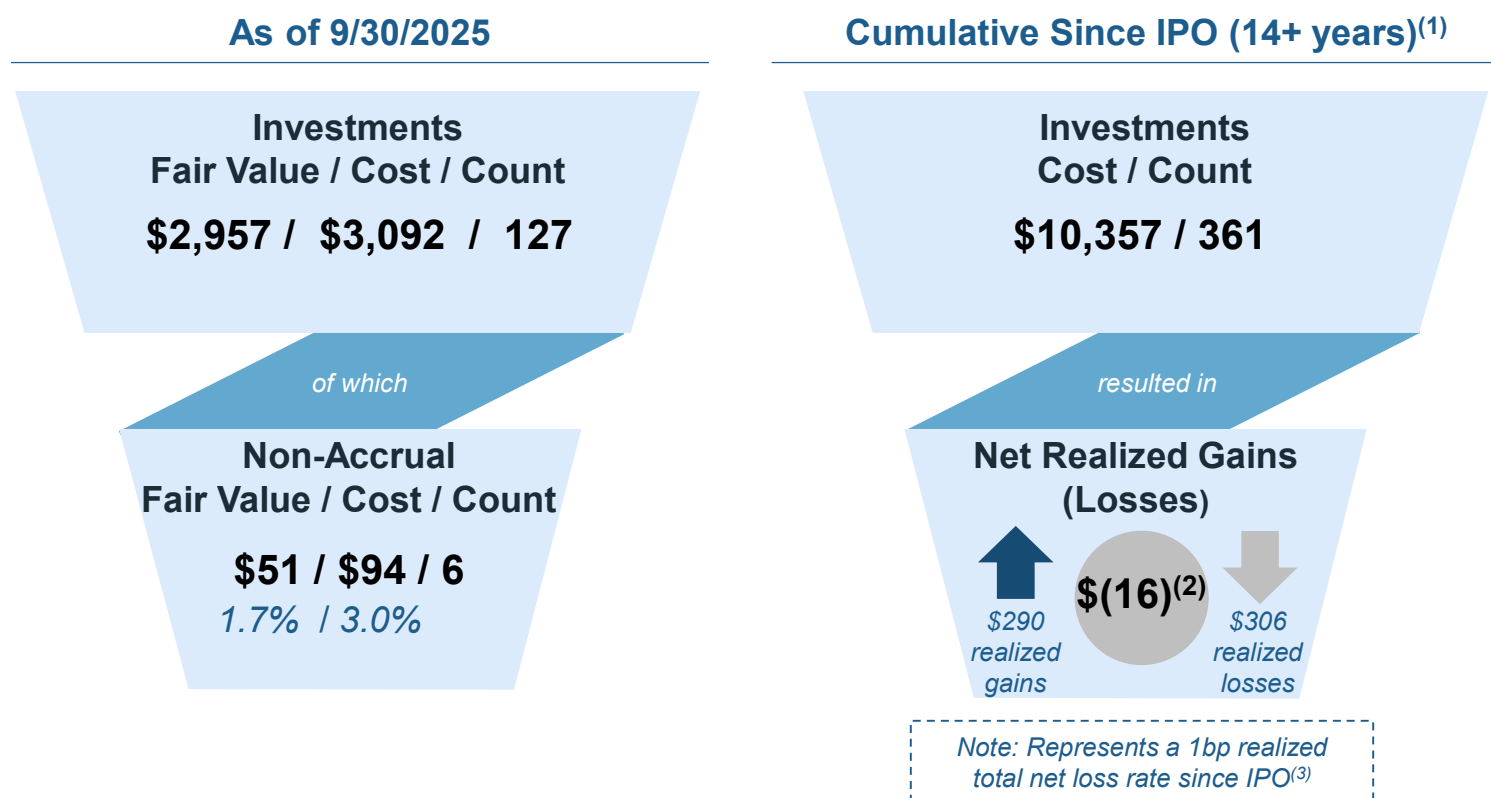

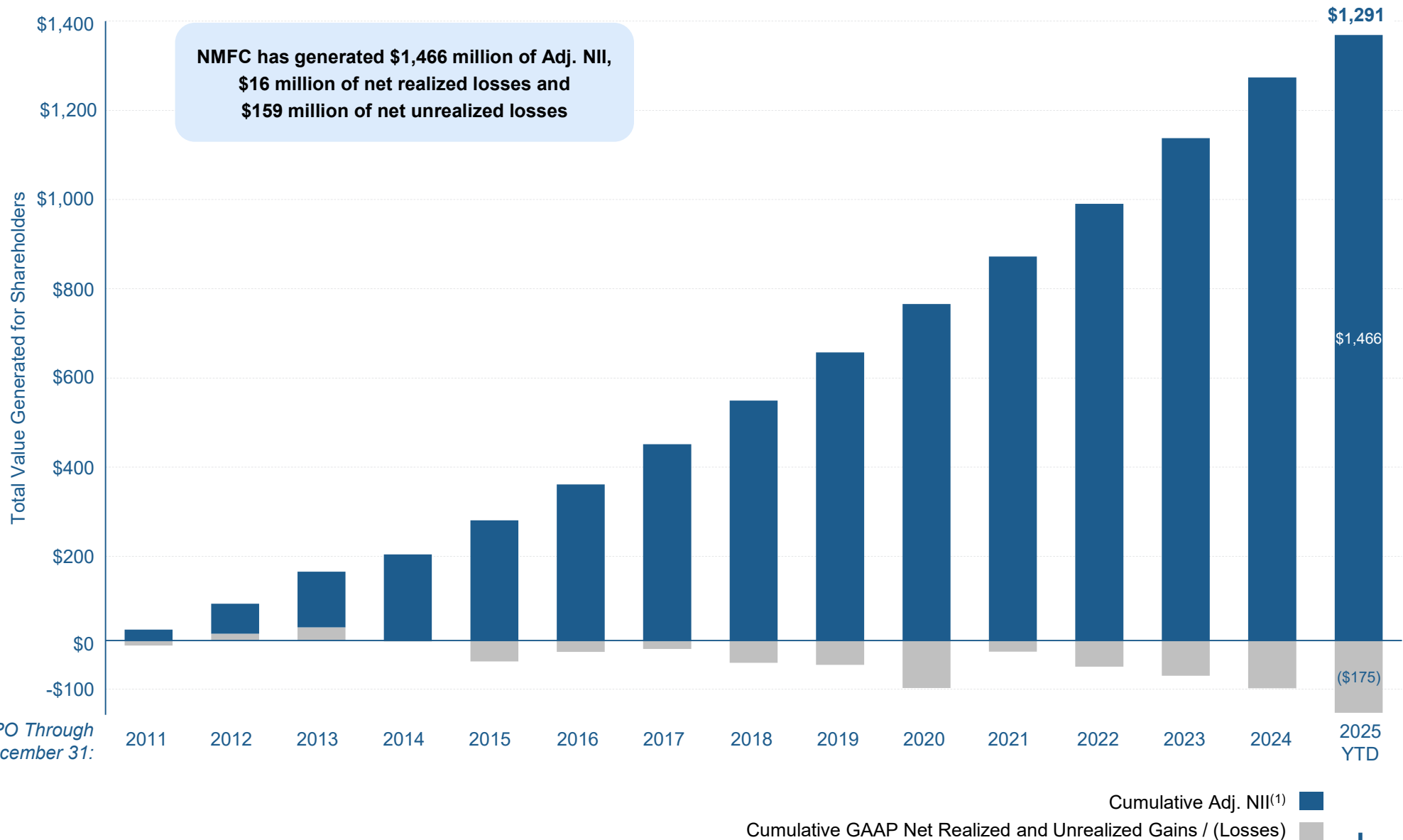

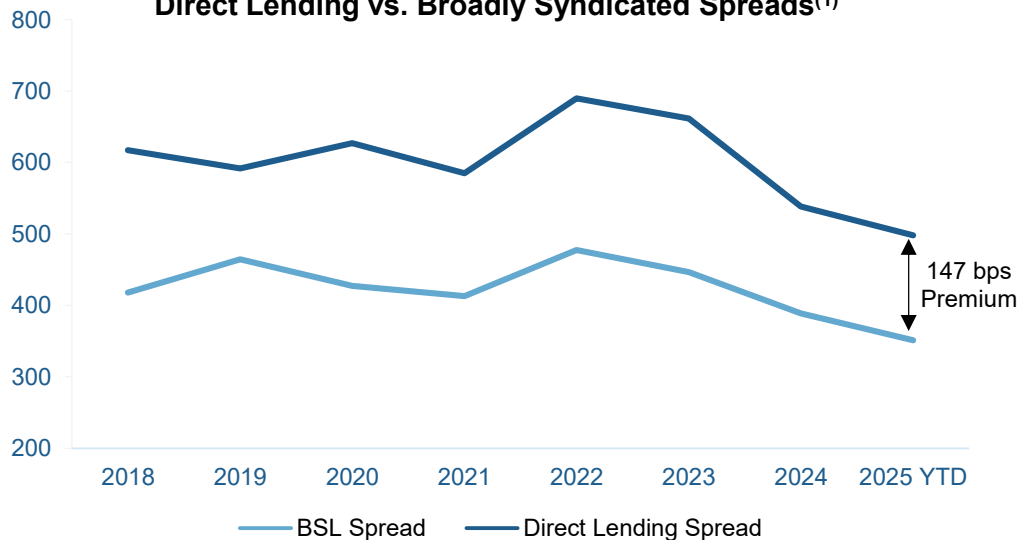

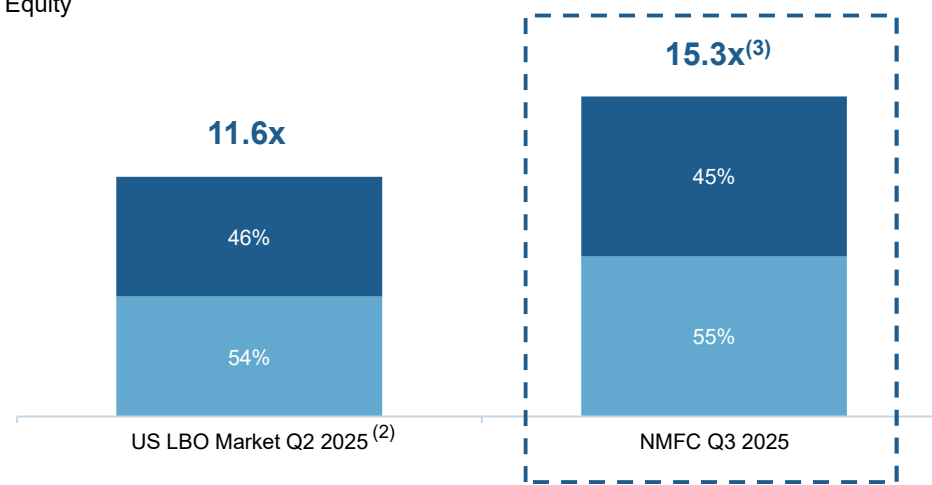
Direct Lending continues to provide attractive returns...

Direct Lending vs. Broadly Syndicated Spreads⁽¹⁾



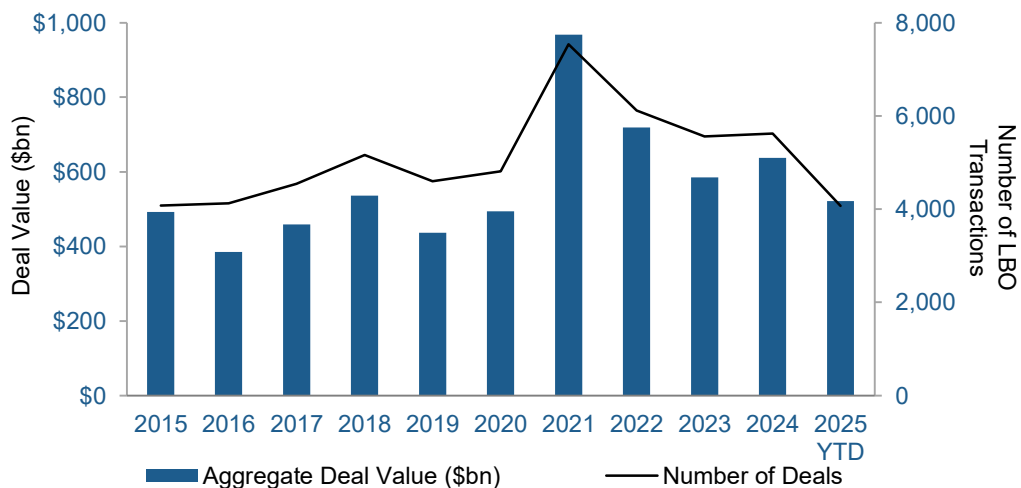

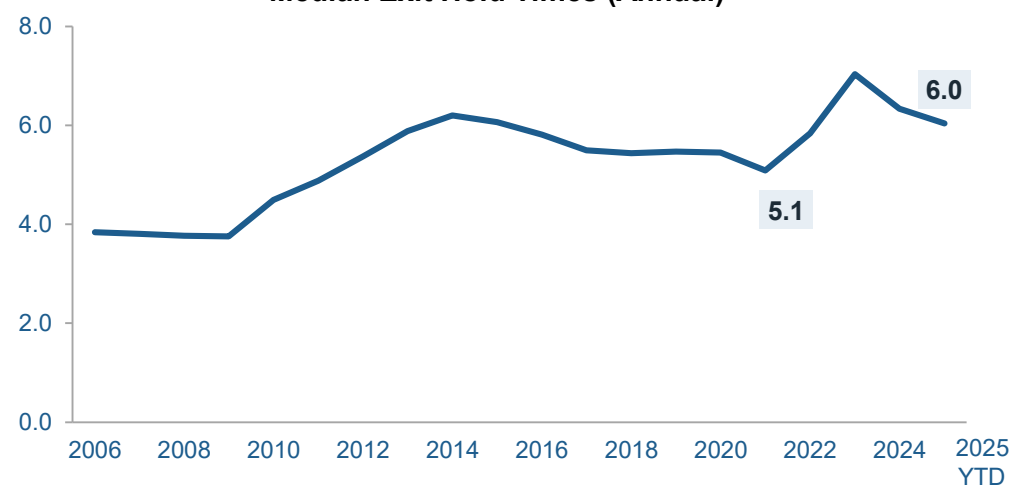
LBO deal volume remains subdued...

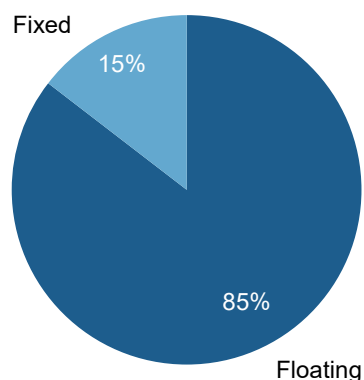

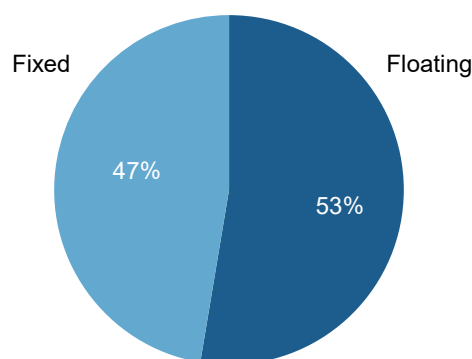
Asset Mix

(Aggregate par value of \$2,461 million as of 9/30/2025)⁽¹⁾



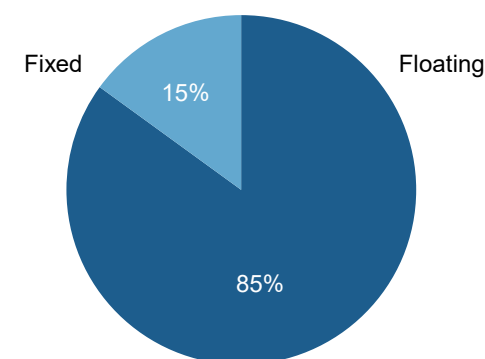
Liability Mix

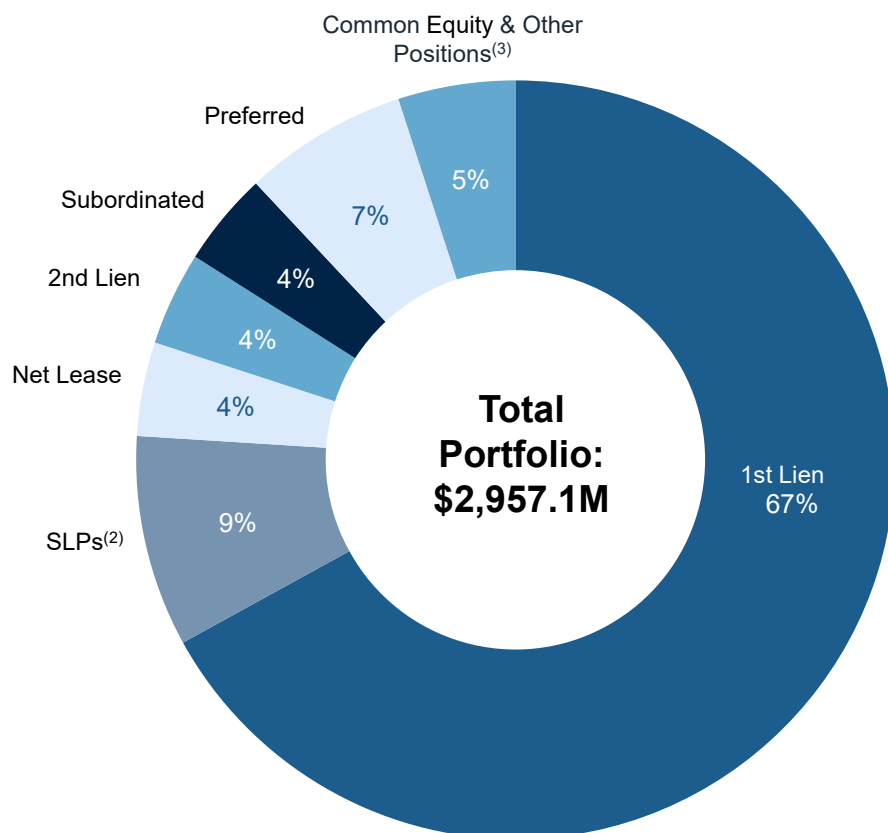

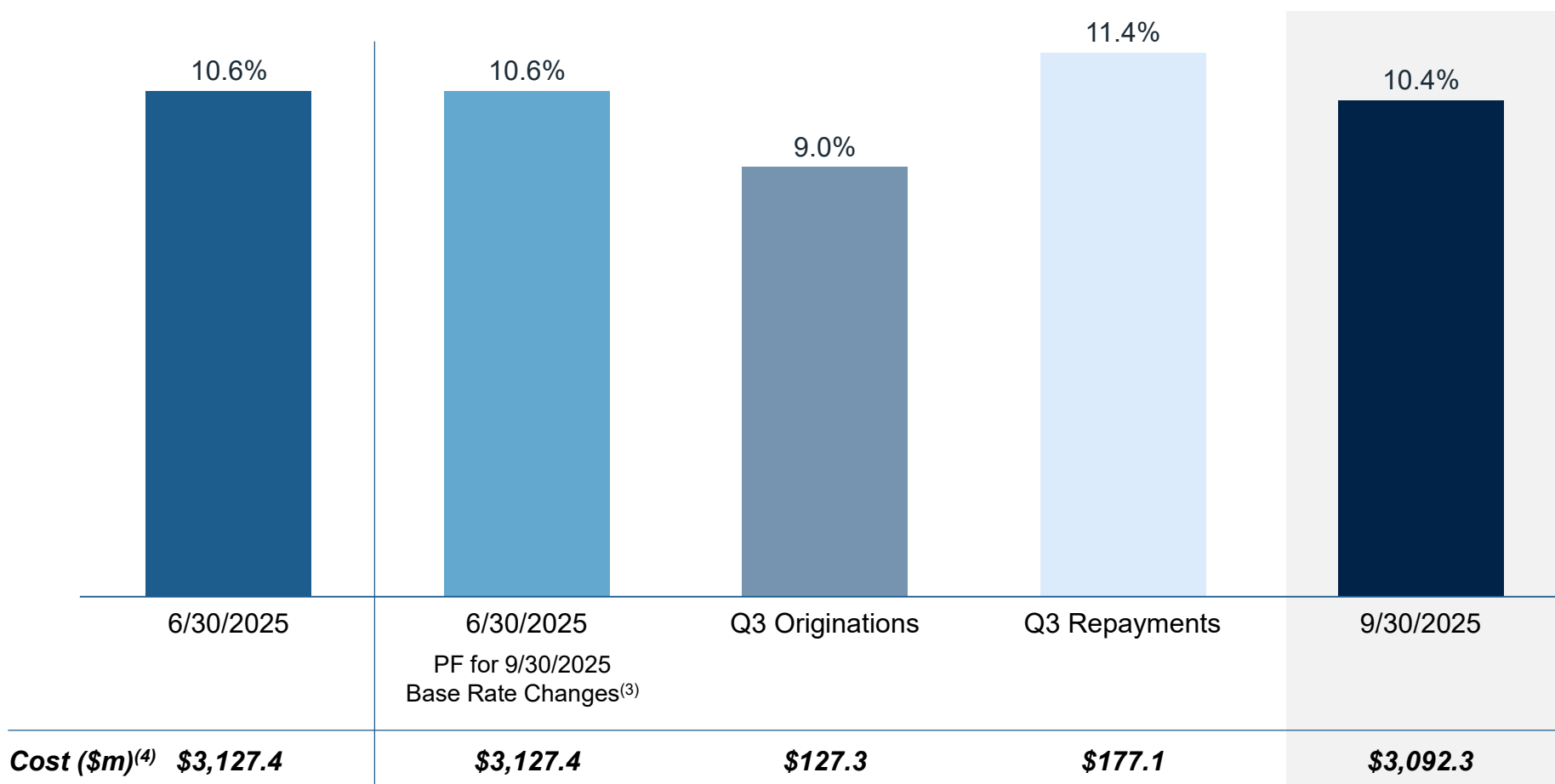

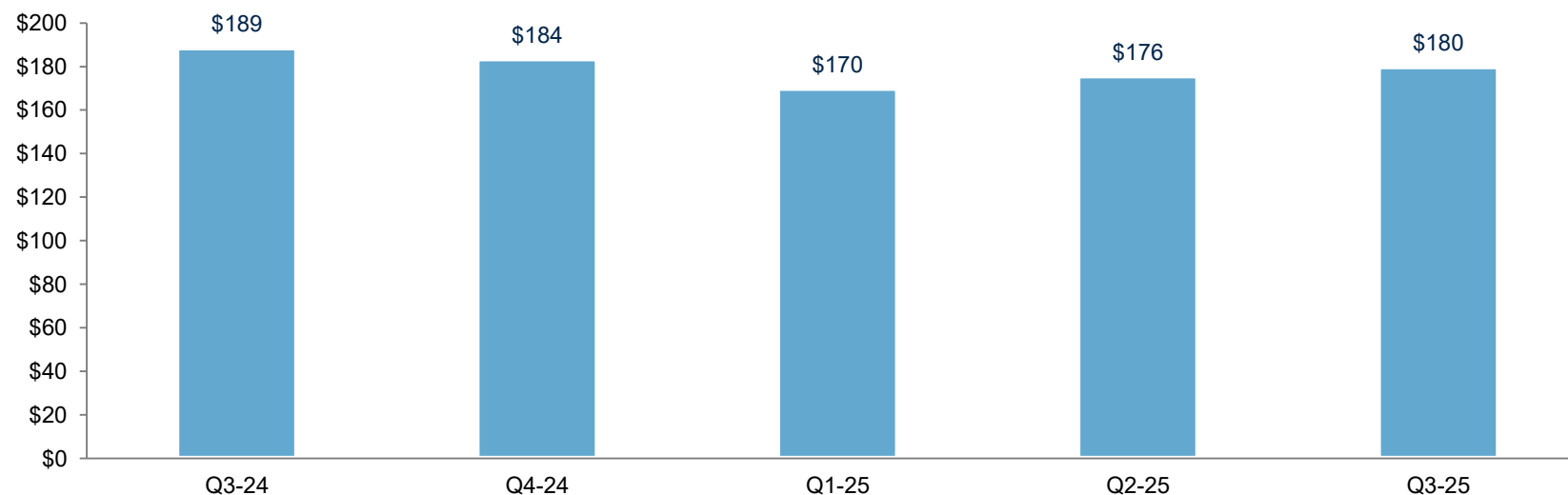

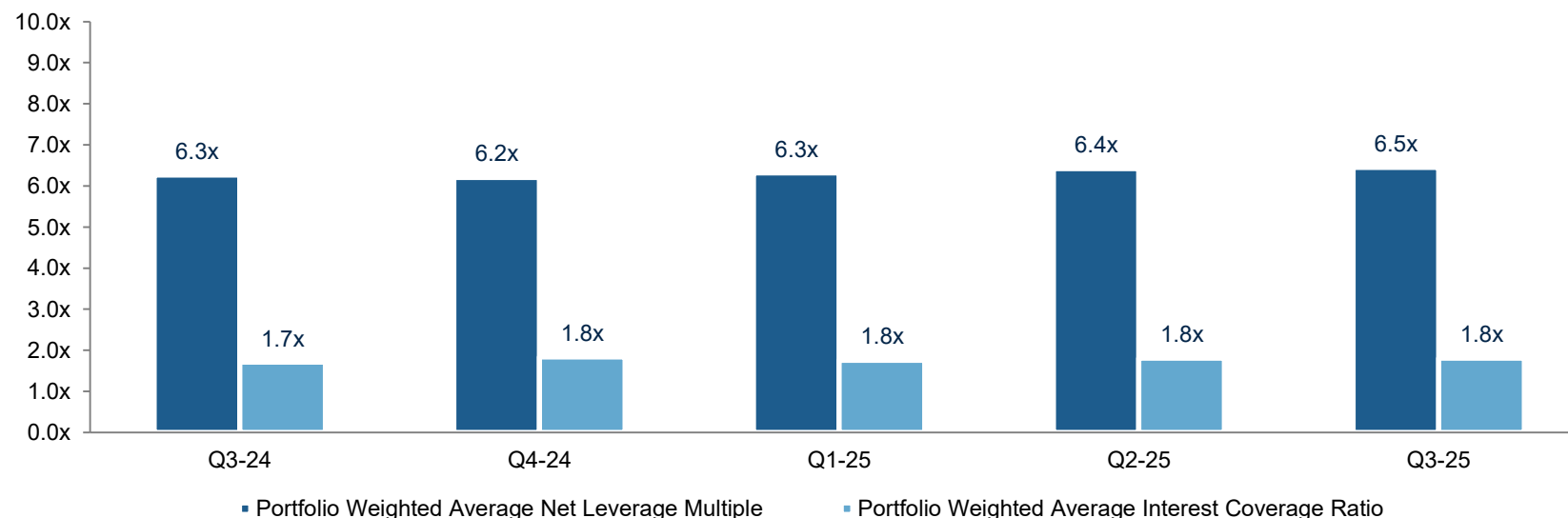
Portfolio Company EBITDA and Credit Statistics

Portfolio Weighted Average EBITDA⁽¹⁾



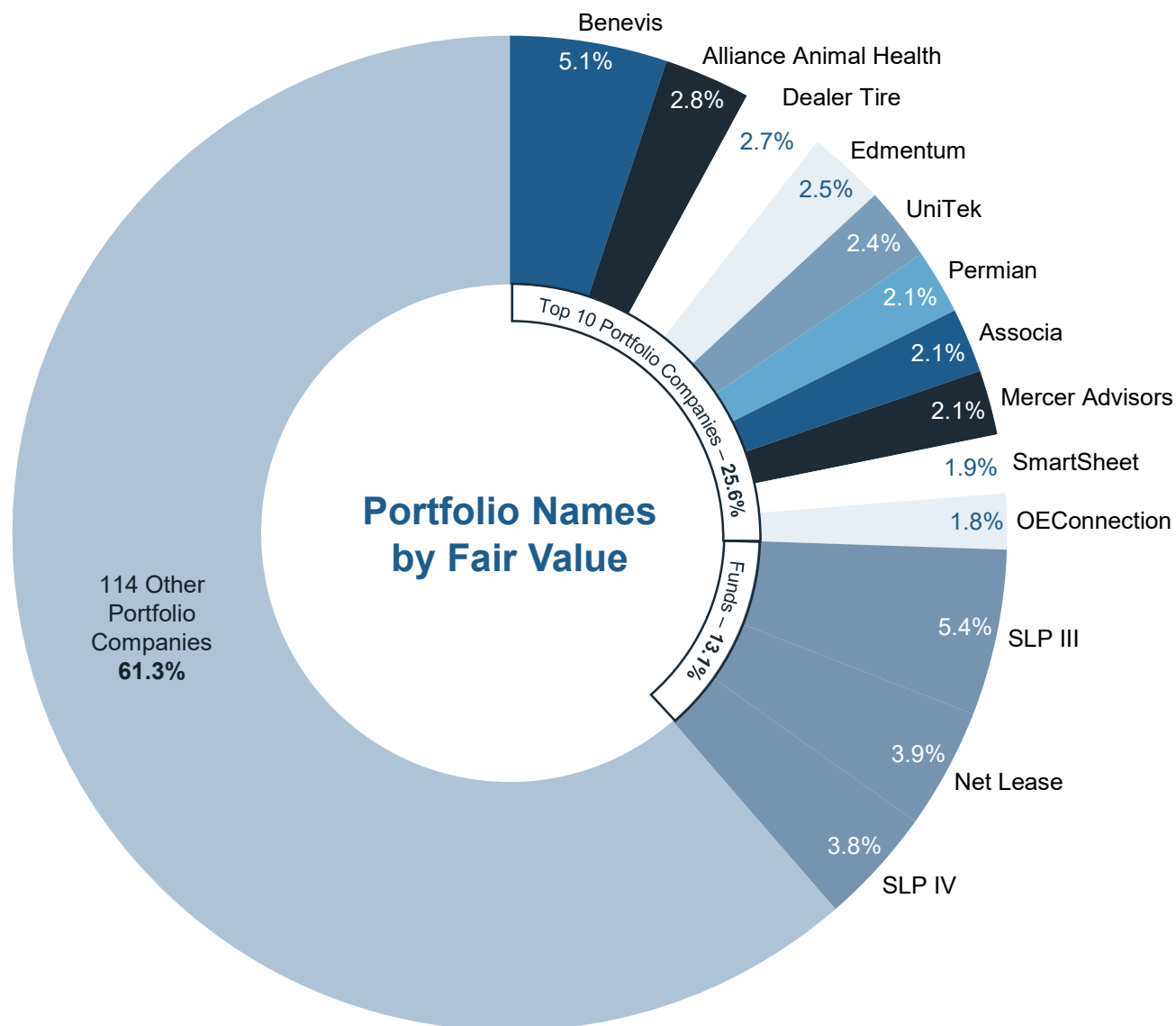

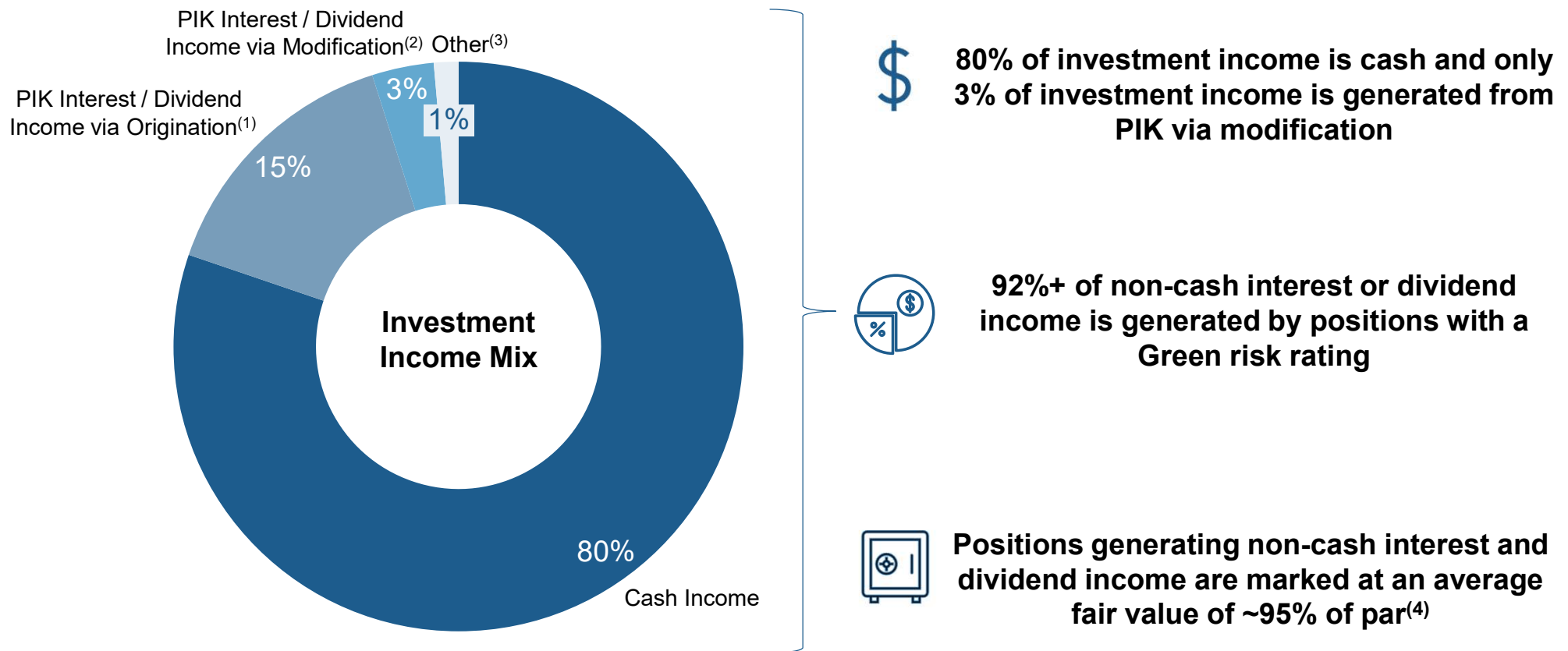

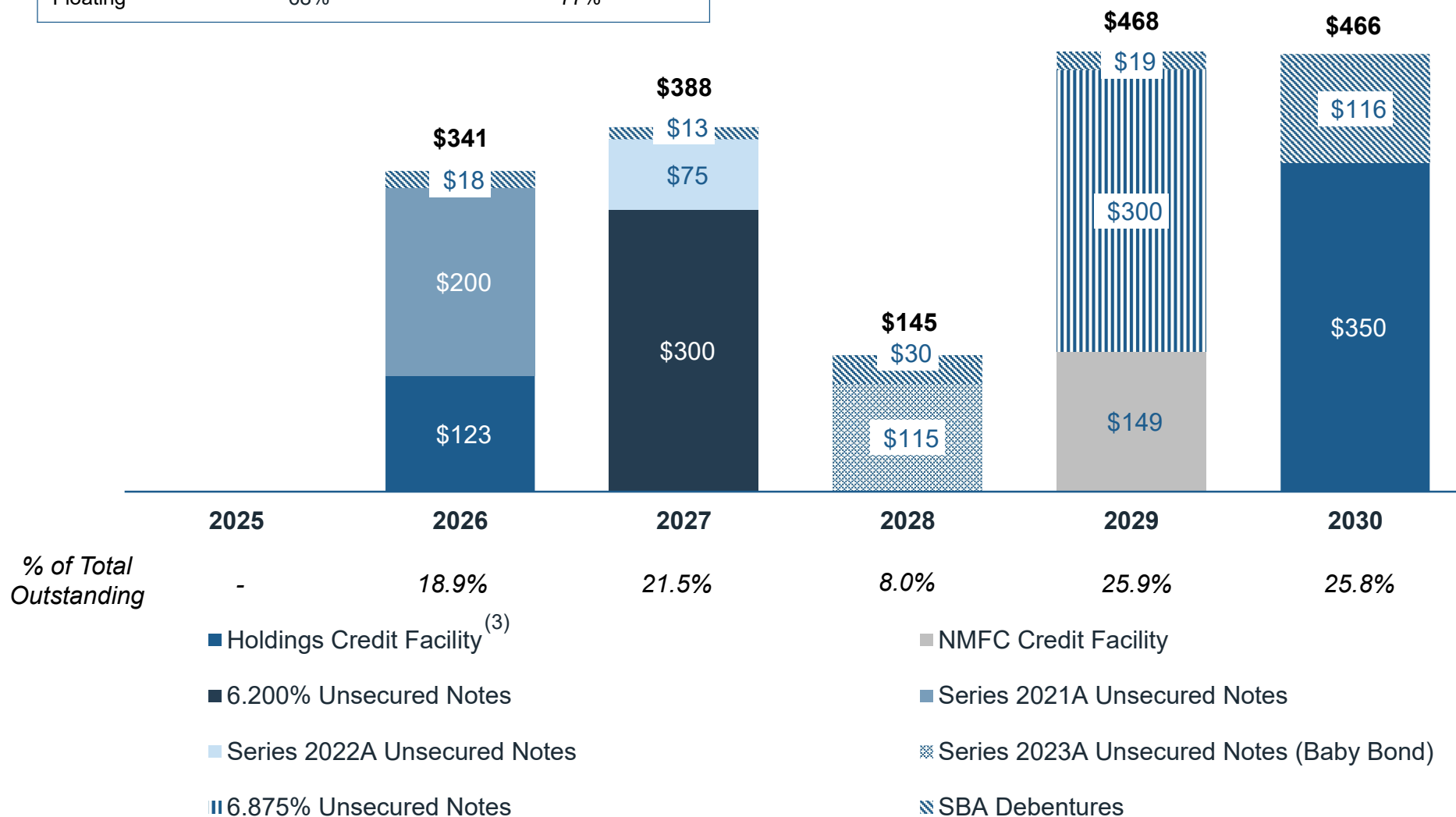

Unsecured Issuances

- NMFC has issued multiple series of unsecured debt: \$200 million in 2021, \$275 million in 2022, \$175 million in 2023 and \$600 million in 2024
- Two Public IG bonds issued in 2024, with maturities in October 2027 and February 2029; both have been hedged to floating
- Continued issuance in IG bonds provides liquidity at different points along the curve
- \$214 million⁽¹⁾ of debt maturing by Q1 2026; while we have sufficient liquidity, we remain focused on continually accessing the public bond market to refinance the upcoming maturities

Ratings

- Investment Grade rating by Moody's (Baa3/stable), Fitch (BBB-/stable) and KBRA (BBB-/stable)
