

INDEPENDENT LIMITED ASSURANCE STATEMENT

To: The Stakeholders of Herbalife Nutrition

Introduction and objectives of work

Apex Companies. LLC (Apex) was engaged by Herbalife Nutrition to provide limited assurance of select GHG emission, electricity and natural gas consumption, social and production data. This Assurance Statement applies to the Subject Matter included within the scope of work described below.

This reported information and its presentation ('the Subject Matter') are the sole responsibility of the management of Herbalife Nutrition. Our sole responsibility was to provide independent assurance on the accuracy of the Subject Matter.

Scope of work

The scope of work was limited to assurance over the following information for Reporting Year 2022 (the 'Subject Matter'):

Packaging:

- Total rigid plastic in packaging;
- Total use of virgin rigid plastics;
- Percent of virgin rigid plastic content within total rigid plastic packaging; and,
- Percent of recycled content within total rigid plastic packaging.

Diversity Equity and Inclusion (DEI)

- Total number of employees;
- Total number and percent of women in workforce;
- Total number and percent of women in management (manager and up);
- Total number and percent of women in Executive Management (Vice President and up);
- Total number and percent of racial minorities in workforce (in the US); and,
- Total number and percent of racial minorities in management (manager and up in the US).

Greenhouse Gas Reporting

- Herbalife Nutrition's Reporting Year 2022 GHG emissions, electricity and natural gas consumption for 11 facilities (HIM Changsha, HIM Suzhou, HIM Nanjing, HIM Winston Salem, HIM Lake Forest, La Distribution Center, Memphis Distribution Center, Hagerstown Distribution Center, HP1, HP3, and LA Live)
 - Operational Control
 - 11 facilities
 - o Types of GHGs: CO2, N2O, CH4

Our assurance does not extend to any other information reported by Herbalife Nutrition.

Reporting Criteria

- The Subject Matter needs to be read and understood together with the Herbalife Nutrition's reporting methodology, as described in the subject matter
- World Resources Institute (WRI)/World Business Council for Sustainable Development (WBCSD)
 Greenhouse Gas (GHG) Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2)

Reference Standard

- ISO 14064-3 Second Edition (2019-04): Greenhouse gases -- Part 3: Specification with guidance for the validation and verification of greenhouse gas statements
- International Standard on Assurance Engagements (ISAE) 3000 Revised, Assurance Engagements Other than Audits or Reviews of Historical Financial Information (effective for assurance reports dated on or after Dec. 15, 2015), issued by the International Auditing and Assurance Standards Board.

Limitations and Exclusions

Excluded from the scope of our work is any assurance of information relating to:

- Activities outside the defined assurance period of calendar year 2022;
- Based on Reporting Year (RY) 2021 emissions inventory, mobile and fugitive emissions were deemed de minimis and are excluded from RY 2022 inventory.

This limited assurance engagement relies on a risk based selected sample of sustainability data and the associated limitations that this entails. This independent assurance engagement and statement should not be relied upon to detect all errors, omissions or misstatements that may exist.

Responsibilities

The preparation and presentation of the Subject Matter are the sole responsibility of the management of Herbalife Nutrition.

Apex was not involved in the preparation of the Subject Matter or of the Reporting Criteria. Our responsibilities were to:

- Obtain limited assurance about whether the Subject Matter has been prepared in accordance with the Reporting Criteria;
- Form an independent conclusion based on the assurance procedures performed and evidence obtained;
 and
- Report our conclusions to the stakeholders of Herbalife Nutrition.

Assessment Standards

We performed our work in accordance with Apex's standard procedures and guidelines for external
Assurance of Sustainability Reports and International Standard on Assurance Engagements (ISAE) 3000
Revised, Assurance Engagements Other than Audits or Reviews of Historical Financial Information
(effective for assurance reports dated on or after Dec. 15, 2015), issued by the International Auditing and
Assurance Standards Board. A materiality threshold of ±5-percent was set for the assurance process.

Summary of Work Performed

As part of our independent assurance, our work included:

- Assessing the appropriateness of the Reporting Criteria for the Subject Matter;
- Conducting interviews with relevant personnel of Herbalife Nutrition;



- Reviewing the data collection and consolidation processes used to compile Subject Matter, including assessing assumptions made, and the data scope and reporting boundaries;
- Reviewing documentary evidence provided by Herbalife Nutrition;
- Agreeing a selection of the Subject Matter to the corresponding source documentation;
- Assessing the disclosure and presentation of the Subject Matter to ensure consistency with assured information.

Percent of virgin rigid plastic content within total rigid plastic packaging: 97.53%

Percent of recycled content within total rigid plastic packaging: 2.47%

Percent of women in the workforce: 51.3%

Total number of women in management (manager and up): 1116
