## **Bristow Group Promotes Chipman Earle To Senior Vice President, Chief Legal And Support Officer, And Mary Wersebe To Vice President, Human Resources**

Earle most recently served as Bristow's senior vice president, chief legal officer and corporate secretary since May 2014. He previously served as Bristow's senior vice president, general counsel and corporate secretary since July 2012. Prior to joining the company, Earle worked as the head of legal operations for Transocean Ltd. and previously as a corporate and securities attorney at the law firm of Baker Botts L.L.P. in Houston, Texas.

"Mary has been a valued human resources leader who has helped drive business results," said Baliff. "She has been instrumental in her role as interim chief administration officer and we will continue to benefit from Mary's expertise in these areas."

Wersebe has served as Bristow's acting chief administrative officer since June 2016. She previously served as director human resources global operations. Prior to joining Bristow in

May 2014, Wersebe was director human resources at Exterran.
