Clean Energy Expert Angelina Galiteva Joins Emissions Advisory Group

"As is evidenced by the recently announced Phase 2 order (detailed in a [prior press release](#)) for emissions retrofit kits, our technology successfully reduces the emission of harmful pollutants from spark-ignited reciprocating engines to levels on par with fuel cells," said Robert Panora, Tecogen President, COO and lead of the Advisory Group. "We welcome the expertise and guidance of Ms. Galiteva as we work to apply this revolutionary technology to automotive engines."
