Omega Announces Increase in Common Stock Dividend

HUNT VALLEY, Md.--(BUSINESS WIRE)-- Omega Healthcare Investors, Inc. (NYSE:OHI) today announced that the Company's Board of Directors declared a common stock dividend of \$0.48 per share, increasing the quarterly common dividend by \$0.01 per share over the previous quarter. The common stock dividend is payable November 15, 2013 to common stockholders of record as of the close of business on October 31, 2013.

At the date of this release, the Company had approximately 119.5 million outstanding common shares.

The Company is a real estate investment trust investing in and providing financing to the long-term care industry. At June 30, 2013, the Company owned or held mortgages on 477 skilled nursing facilities, assisted living facilities and other specialty hospitals with approximately 55,075 licensed beds (52,890 available beds) located in 33 states and operated by 47 third-party healthcare operating companies.
