Kenny Chesney to Launch "Big Revival Radio" on SiriusXM

Limited-run channel to feature "Town Hall" special with Kenny Chesney

NEW YORK, Sept. 16, 2014 /PRNewswire/ -- SiriusXM announced today that it will launch "Big Revival Radio," a limited-run channel featuring the music of award winning country singer Kenny Chesney.
