

Tecogen Sells Ultra Emission System to the Gage Canal Company

WALTHAM, Mass., Feb. 11, 2015 /PRNewswire/ -- Tecogen® Inc. (NASDAQ: TGEN) today announced the sale of its patented emissions reduction system to the Gage Canal Company in Riverside, California. The Gage Canal Company, in operation since the 1880's, supplies water for irrigation and other uses in the area. The 20 mile canal system is known for its historic significance to the development of Southern California and, in particular, the expansion of citrus agriculture in the region.

The emissions after-treatment system will be applied to an existing 15 liter natural gasfueled Caterpillar engine that pumps below-ground well water to the canal. The Tecogen
Ultra emissions system is being sold as a retrofit kit to the Gage Canal Company. The kit
closely resembles the design of the Ultra system in operation since 2013 at the nearby
Eastern Municipal Water District (EMWD) Booster Station located in Moreno Valley,
California. The EMWD installation was the subject of a Company press release two months
ago detailing their purchase of an additional Ultra system for a 48 liter biofuel engine at their
Moreno Valley Regional Water Reclamation Facility.

"When we heard about Tecogen's after-treatment system, we arranged a visit to the EMWD demonstration site and came away impressed," said Ross Lewis, the Gage Canal Company's General Manager. "The system is straightforward and appears highly effective. We are optimistic that our experience will duplicate the EMWD's of hassle-free emission compliance. If so, we will explore retrofit opportunities with our other engines."

"This sale is part of our strategy to place Ultra systems with both public and private water companies that operate multiple engines facing emissions compliance issues," said Robert Panora, Tecogen COO. "The initial sale to Gage Canal will serve to provide confidence in our system to other water companies. We expect Gage Canal will purchase additional systems and, of course, inform others in the industry about their positive experience."
