

Direct Deposit Instructions and Information (Optional):

You have the option to sign-up for Direct Deposit where your payments will be directly deposited into your checking or savings account instead of receiving a physical check every month. Direct Deposit allows you faster and timely access to your payments. This option is no cost to you; however, your bank may have fees associated with Direct Deposit transactions. Physical checks are mailed out via USPS mail and delivery times may vary, therefore, it is in your best interest to sign-up for this option.

To sign-up for Direct Deposit:

- 1. You must have an e-mail address where Antero Resources will e-mail your statement detail
- 2. Fill out the Electronic Funds Transfer Authorization Agreement form
- 3. For account verification please enclose a void check (The name on the check must match the payee/ owner name or company name we have on file for the account). A letter from your bank on Bank Letterhead may also be provided for account verification. This letter must include your name, account number, and routing number. PLEASE NOTE if the account is a checking or savings account on the letter.

Please note: If you do not provide ALL of the requirements above you will not be opted into Direct Deposit and will receive physical checks.

You may receive this form multiple times, however, only one is needed to be filled out and returned to Antero Resources. The Electronic Funds Transfer Authorization Agreement will cover all properties associated with this payee/owner number.
