Subject: Cliffs Steel Inc. Weirton Tin Products


To Whom It May Concern:

We are providing following information concerning the tin products which are manufactured at and shipped from Cliffs Steel Inc.'s ("Cliffs") Weirton tin mill.

1. Cliffs' tin products, which are sold to our customers for use in the manufacture of food or beverage containers, are manufactured in strict accordance with the specifications received from our U.S. container manufacturers.
2. Potentially hazardous chemical substances, such as mercury, polychlorinated biphenyls and asbestos, are not used by Cliffs in the manufacturing of its tin products.
3. Lead, mercury, cadmium and hexavalent chromium are not intentionally added or introduced into Cliffs' tin products. With respect to the New Model in Packaging Legislation, now referred to as the Toxics in Packaging Clearing House or TPC (the previous CONEG Legislation), the combined incidental level of lead, mercury, cadmium, and hexavalent chromium in our products is less than 100 parts per million.
4. Cliffs does not intentionally add or use any of the following allergens in the manufacturing of its tin products.
 - Peanuts, tree nuts including derivatives
 - Fish, shellfish including derivatives
 - Milk products including derivatives
 - Egg products including derivatives
 - Wheat including derivatives
 - Soy including derivatives
5. Cliffs does not make any representations concerning compliance with the FDA's labeling/misbranding requirements as it is not responsible for the final consumer packaging that its tin might be used in.
