Fuling Global Inc. and its subsidiaries (“Fuling”) are principally engaged in the production and distribution of environmentally-friendly plastic serviceware. We sell most of our products to major fast food chains and wholesalers in the U.S. and Europe.

Since our founding in 1992, Fuling’s vision has been to be an international leader in the production of disposable cutlery, straws and other serviceware. We believe that we can continue to produce serviceware of the highest quality without compromising on our dedication to innovation and the environment. We focus on research and development, craftsmanship, manufacturing technology, environmental protection and quality management to ensure that we can provide excellent products reliably and at fair prices. Anything Fuling produces—even something as small as a straw—is imprinted with our culture and values.

We produce our products in our factories in the United States and China. Our four factories in China are all located in Zhejiang Province. Our Wenqiao factory is located in Wenqiao County, Wenling City. Our Songmen factory is located in Songmen Town, Wenling City. Our Sanmen factory is located in Sanmen County, Taizhou City. Taizhou Fuling Plastics Co., Ltd. is one of the top three exporters of plastic kitchenware & serviceware recognized by the China Chamber of Commerce for Import & Export of Light Industrial Products & Arts-Crafts.

Our U.S. factory is in Allentown, Pennsylvania. To facilitate our North American distribution, we operate with four distribution centers in North America: Los Angeles, California; Allentown, Pennsylvania; Toronto, Ontario; and Vancouver, British Columbia.

Fuling holds more than 30 patents focused on environmentally-friendly materials and technology. The company also has obtained ISO9001 quality management system, ISO14001 environmental management system, Hazard Analysis Critical Control Point, Good Manufacturing Practice and U.S. Food and Drug Administration food facility registration certifications. Our patents and certifications are crucial for businesses like ours that serve some of the most sophisticated purchasers of foodservice disposables in the world.

The company has more than 1,500 employees. And almost 100 people work in R&D department has jointly developed environmentally-friendly new materials and products with the Chinese Academy of Sciences.
