

# VERIFICATION OPINION DECLARATION GREENHOUSE GAS EMISSIONS

To: The Stakeholders of Herbalife Nutrition

Apex Companies, LLC (Apex) was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions reported by Herbalife Nutrition for the period stated below. This verification opinion declaration applies to the related information included within the scope of work described below.

The determination of the GHG emissions is the sole responsibility of Herbalife Nutrition. Herbalife Nutrition is responsible for the preparation and fair presentation of the GHG emissions statement in accordance with the criteria. Apex's sole responsibility was to provide independent verification on the accuracy of the GHG emissions reported, and on the underlying systems and processes used to collect, analyze and review the information. Apex is responsible for expressing an opinion on the GHG emissions statement based on the verification. Verification activities applied in a limited level of assurance verification are less extensive in nature, timing and extent than in a reasonable level of assurance verification.

# Boundaries of the reporting company GHG emissions covered by the verification:

- Operational Control
- 10 facilities including
  - Five Herbalife Innovation Manufacturing sites (HIM Changsha, HIM Suzhou, HIM Nanjing, HIM Winston Salem, and HIM Lake Forest) and
  - Five US-based offices and distribution centers with greater than 40,000-square foot occupancy.

Types of GHGs: CO<sub>2</sub>, N<sub>2</sub>O, CH<sub>4</sub>, HFCs

#### **GHG Emissions Statement:**

- Total Natural Gas Consumption: 43,460 megawatt hours (156,456 gigajoules)
- Total Electricity Consumption: 43,542 megawatt hours (156,751 gigajoules)
- Total Energy Consumption (natural gas and electricity): 87,002 megawatt hours (313,207 gigajoules)
- Scope 1: 7,877 metric tons of CO<sub>2</sub> equivalent
- Scope 2 (Location-Based): 16,939 metric tons of CO<sub>2</sub> equivalent
- Scope 2 (Market-Based): 16,939 metric tons of CO<sub>2</sub> equivalent
- Total Scope 1 and Scope 2: 24,815 metric tons of CO<sub>2</sub> equivalent

Data and information supporting the Scope 1 and Scope 2 GHG emissions statement were historical in nature.

## **GHG Verification Methodology:**

Evidence-gathering procedures included but were not limited to:

- Interviews with relevant personnel of Herbalife Nutrition;
- Review of documentary evidence produced by Herbalife Nutrition;
- Review of Herbalife Nutrition data and information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions; and
- Audit of sample of data used by Herbalife Nutrition to determine GHG emissions.

### **Verification Opinion:**

Based on the process and procedures conducted, there is no evidence that the GHG emissions statement shown above:

- is not materially correct and is not a fair representation of the GHG emissions data and information; and
- has not been prepared in accordance with the WRI/WBCSD GHG Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2).

It is our opinion that Herbalife Nutrition has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions for the stated period and boundaries.

A materiality threshold of ±5-percent was set for the assurance process.

Total rigid plastic in packaging: 15,765 metric tons

Total use of virgin rigid plastics: 15,510 metric tons

Percent of virgin rigid plastic content within total rigid plastic packaging: 98.4%

Percent of recycled content within total rigid plastic packaging: 1.6%

Percentage of women in Executive Management (Vice President or higher): 28%
