
THIS COURT ORDERS that:

1. The Order of the Honourable Madam Justice Fitzpatrick (the “**Interim Order**”) pronounced on May 14, 2020 and entered on May 15, 2020, shall be and hereby is varied such that paragraph 21 is deleted and replaced with the following:

The quorum for the Perimeter Meeting is two or more persons, whether present in person or represented by proxy, collectively holding: (a) a majority of the Perimeter Shares entitled to vote at the Perimeter Meeting; and (b) Perimeter Securities representing a majority of the total number of votes attached collectively to the Perimeter Shares, Perimeter Debentures, Perimeter Options and Perimeter Warrants entitled to vote at the Perimeter Meeting.

2. All other terms of the Interim Order, as amended, will continue to be of full force and effect.
3. New World and Perimeter shall be entitled, at any time, to apply to vary the Interim Order or this Supplemental Order.
4. To the extent of any inconsistency or discrepancy between the Interim Order or this Supplemental Order on the one hand and the Information Circular, the BCBCA, applicable Securities Laws or the articles of Perimeter or New World on the other, the Interim Order or this Supplemental Order will govern.
5. Rules 8-1 and 16-1(8)-12 will not apply to any further applications in respect of this proceeding, including the application for the Final Order and any application to vary the Interim Order or this Supplemental Order.
6. Perimeter shall provide notice of the granting and substance of this Supplemental Order to Perimeter Securityholders by posting on Perimeter's website under Investor Relations> News/Events.
