Update April 26, 2022

China Update - The lockdown policy in Shanghai is not lifted yet and may not be terminated until early May, considering the upcoming long holiday (CN's Labor Day holidays Apr30-May04, will be followed by the coming Labor Day holidays schedule this Thursday Apr28).

- Ability to move small parcels, but restrictions in weight resulting in greater delays. See DHL's latest update below with changes in red
- Shanghai airport operates but remains constrained due to shortage of manpower. Air cargo carriers
 at PVG are being forced to reroute to other nearby cities (Zhengzhou, Wuhan, Beijing, Nanjing,
 Hangzhou, Chongqing, Chengdu etc. but becoming congested) with strict control on trucks and
 drivers in/out of the airport.
- FCL remains in operation in SHA port while LCL is still limited, Ningbo is an alternative.
- SHA's Customs operates but low efficiency as a shortage of manpower.
- Domestic pick up / delivery is still limited at Shanghai Pudong & Puxi, subject to certain areas with granted permit and trucker source. Cross-city transportation is critical and check by case.
- Inbound Dangerous goods to PVG airport are suspended while Waigaoqiao and Yangshan ports have limitations.
- For Fedex, there's still no pick-up/delivery service in Shanghai, only offering Drop-off & Self pick up services.
- For the Shenzhen/Hong Kong border, cross-border trucking is limited while it's mainly for necessities including food and medical supplies.

The situation is fluid, for the time being we would keep monitoring and providing updates if there is an obvious change.

East Chiana (Shanghai)

- On March 27th, Shanghai authorities in China announced that the city of Shanghai will be locked down in two phases to prevent and control the spread of COVID-19. Initially the Pudong area (East Shanghai, where the International Airport is located) will be locked down effective March 28th to April 1st and subsequently the Puxi area (West Shanghai) will be locked down effective April 1st to April 5th.
- Plan for a two-week delay in shipments from April 27th May 4th.
 - Small parcel There is no DHL & Fed Ex local operations and outbound and inbound processing capacity in Shanghai. Shipments that did not leave by April 27th will not resume until at least May 5th.
 - Heavy air and ocean shipments through the airport and ports are stopped.
- When resumed and as seen with south China, expect a 3+ day delay in small parcel for several business days ramping back down in 1- 2 weeks. Ocean and Heavy air expect one week delays for a longer period of time.

China (Shenzhen/ Dongguan):

- All locations are no longer under lock down.
- DHL small parcel shipments have predominantly recovered; one day additional delay for current transit times with clearance to US / MX destinations 5-7-days.
- Heavy air remain a last resort option. Expect up to one additional delay in scheduling; two weeks total.
- Ocean transportation has resumed. Expect one week additional delay.

China – Other cities





- Other cities continue to have some reduced trucking operations. Cities such as Ningbo around Shanghai have greater traffic and rerouting which is causing additional delays.
- Shipping lines and Customs have arrange shift work and deploy limited resources and expect certain delays of efficiency.
- Air operations are still operative at the moment but we will keep monitoring the status.

Hong Kong:

No longer any restrictions with minimal additional delays.

Russia/Ukraine

• Still no current tangible impacts on our shipments in Europe.
