#### **Covid Logistics Update 5/10**

Further to our communication last week, the lockdown in Shanghai continues but it is slowly getting better across East China.

#### Shanghai

- DHL will resume their outbound services from Shanghai (SHA), Zhejiang Area (HGH) and Jiangsu and Anhui Area (SZV, PVG) – with a temporary weight limit restriction of 100 kg per pick up (customer collection) per day until further notice.
- Kunshan lockdown is lifted.
- Shanghai air terminal is operating but remains constrained by manpower shortage.
- Ocean terminal remains in operation and LCL is recovering.
- Trucking local and cross cities are resuming but still limited.

Beijing - PEK has more areas forced into lockdown, but airport and inland trucking still operates without huge impact.

Shenzhen / Hong Kong - Cross-border truck situation is slowly getting better but barge remains in use at large.

Transpacific ocean transit time continues to average over 110 days. This is primarily driven from continued delays in staffing at ports, trailer availability and trucking pickup long haul delays.

Diesel and gas prices continue to rise, providing increased cost pressure on all modes of transportation. Diesel fuel cost broke the 2005 record this week

Gasoline cost is again on the rise – a few cents below record pricing from 6 weeks ago.

Small parcel delays in delivery and staffing at airports continue to result in 1-2 day delay in US transportation and up to 1 week in international air. SMTC continues to use and find DHL the best alternative for all international air shipments.

The situation remains very fluid. We continue to monitor manufacturing operation and monitoring outbound shipments. We will continue to provide updates when / as obvious changes occur.

During this period, All DHL staff and facilities remain safe. CANGTW arranges some staff to live and commute to get off work together, while the rest of staff work at home to provide protect services, Import and export service at CANGTW remain normal. There may be delays in related email inquiries and telephone answering, please keep traces at minimum and avoid escalations.
Beijing Gateway	All IB shipments transit through PEKGTW must be sterilized and be staging for at least 10days before next step, please expect delay transit service at PEKGTW for shipments destined to all PEK/TSN/BJS/XIY SVCs.
